7) NEW BUSINESS

(A) EVALUATIONS DEBRIEF (20 MIN)

Jackie Carson provided update on feedback as provided by the Division Directors as they were frontline during evaluations
Discussion around weighting in U10 & U12 divisions
Third party evaluator felt rushed, requested more time between ice slots, very little movement between groups after UAA
Teams appear to be well-balanced
Juggling of ice slots had to be done for U12 so stations are done
Should U10 Step 1 & 2 be evaluated by the third party VS. in-house if
Third party is being paid for association as a whole, includes U10
Jackie to ask third party how to better use ice time for U10 division
Third party was responsive and great to deal with as a whole, "trust the process" and had valid points on how to do evaluations
Groups could potentially be correspond to team size
Scheduled times to discuss results and form teams

If AA evaluations begin before September long weekend, RAB to have sanctioning from RAB, Ice Allocator working on ice acquisition. Possibility to have time between AA cuts and remaining evaluations.

Coach pick zone to be reduced? Discussion among board at later

Potential to have more flexibility with divisional skate numbers, adjust to have more open-ended options to adjust accordingly after discussion with third party evaluator

Board to do better with U12 - coaches have more information on goalie Interest

(B) REPOOLING MEETING (5-10 MIN)

Referees: shortage of officials, respect for officials need to be reiterated. SGRA is short refs, pool is not being restocked to keep up with number of referees leaving. Plan to form committee on referee applications & retention.

Fenna Poelzer, discussing with 3-on-3 in St. Albert for potential to try out reffing without committing, Step 2 games should have refs on ice. No refs in Step 1 & 2 provide a shock to players going to U12 as calls not made during Step 1 & 2. Potential to have exhibition games played for referees to gain experience. Target is one season experience (with mentor) before refs are with one other ref. Hiring in spring as opposed to have Applications come in August.

Fenna to confirm referee clinics going forward.

(C) COMMITMENT TO ATTEND - PROVINCIALS (U14-U19) (5 MIN)

Teams to commit to attend by December 15, 2022.

BGL will run playdowns, as opposed to RAB.

Budget forecasted for \$7,000 for RAB membership fees, will potentially need \$6,000 (\$500/team). SGRA to cover the cost of Playdowns. Teams will pay for Provincials.

U10 paid for by SGRA.
