### Ice Report:

Evaluation schedule ran smooth. Very little changes to the schedule. We will be starting base week for most teams on September 18<sup>th</sup>. I have attached the Ice Allocation Policy as a review for directors. Once all teams are made and on Ramp, I will be able to start scheduling team practices.

#### Important Dates:

September 26 – Team Declaration

October 6 – Association must provide BGL with all team staff contacts.

October 7 – Session 1 schedule will be distributed. Once the schedule comes to me, I will send it to the team managers.

October 13 – Session 1 games begin for all divisions except U10.

October 20 – Session 1 games begin for U10.

November 9 – Self Advance and Self-Retreat deadline.

November 10 – Second Session Blackouts must be sent to BGL. My deadline for teams to submit to me will be November 6.

November 19 – Last day for session 1 games for re-pooling.

December 8 – Session 2 games begin for all divisions.

## Number of games played by division in Session 1:

U10: 6 games (games may be played during re-pooling)

U12-U19: 8 games (games may be played during re-pooling)

AA: 6-8 games – this will be determined by the associations at the declaration meeting on

## Blackouts:

Non-AA will be allowed 3 non-weather reschedules per season.

AA will be allowed 4 non-weather reschedules per season.

Non-AA will be granted 1 blackout request for Session 1 and 2 blackout requests in Session 2.

AA will be granted 3 blackout requests anytime.

I have set up Google forms for managers to fill out. Requests are required to be put through these forms. I get way too many emails to sort through. This will make sure that stuff is tracked and not missed.

They are:

**Team Activity Request** – This will be for team events where practice either needs to be cancelled or avoided at a certain time.

**Tournament Blackout Request** – If a team applies for a tournament, I like to know ahead of time so I can keep it on my radar. This is what form to use.

**Confirmation of Tournament Status** – This form is used to let me know what the status is of all tournaments a team has applied for.
