- The U16A team had a player that received a Match penalty for "fighting" and received a mandatory 1 game suspension through Ringette Canada and RAB imposed an additional 3 games for "punching.". Player responded to RAB prior to the Director being notified of the suspension. Director later requested video and was provided a SGRA coach. Video determined to not what was described and reported. Actions were more consistent with "Rough Play" as listed in the Official Rulings Book. No appeal, as RAB notified in the last one of the business week, and 3 of 4 games were served the following weekend.
