8) NEW BUSINESS

(A) REGISTRATION FEES

Allison Wilson proposing introducing a reduced registration fee for **NEW** U10 players. This approach would minimize the financial impact on our organization (from a league wide decrease in registration fees) while still helping to ease the financial burden for families new and young to organized sports. This reduction will help grow our league.

I believe this represents a fair compromise and would like your input at the meeting on Tuesday.

If we register 35 new U10 players under this model, the organization would experience an estimated revenue reduction of approximately \$4,725 in registration fees and be an estimated \$14,000 instead of \$18,725.

Reducing the registration fee for first-time U10 players (new to ringette) by approximately 25% (\$400)—similar to the early registration discounts offered in older age groups—may help attract new families and help reduce the financial barriers to participation.

Allison motions to reduce rates for first time players into U10 S1 and S2 from 535 to 400 S3 from 775 to 580

(B) AA UPDATE

- 2 players from SGRA were selected to take part in Ringette Canada U17 camp
- AA committee met and started documentation to present plan to Ringette Alberta
- This year AA will be status quo and all associations will manage their teams as normal
- New process will start with 14AA, and each division will do their own evals and then protect the players they want. From there players will go to a central evaluations and teams can then draft to complete their teams.

(C) FUNDRAISING DIRECTOR - REVIEW AND AMEND RESPONSIBILITIES AND JOB DESCRIPTION

- Fundraiser Director role job responsibilities was never updated. Tiffany has updated.
- For next season will look at having the Fundraising director and bingo and gaming coordinator work together to split responsibilities.
- Will look at having all incoming funds (except registration) go into the same "Fundraising" umbrella to be reported on monthly at meetings.

(D) POLICY AND HANDBOOK UPDATES

- coach manager handbook
 - On page 4 of our coach/manager handbook, this needs to be amended: SGRA
 also requires an up to date RCMP Criminal Record Check for all team staff.
 Deadline to have completed criminal record checks in to the Director of Coaching
 Assessment & Development will be no later than November 15 of the current
 playing year.
 - It should state: RCMP Vulnerable sector check versus criminal record check.
 - Also, our screening policy should also reflect this date of November 15th.

- Coach manager handbook needs updating regarding cheque collection
- Breanne makes a motion for voting Directors to be exempt from association fundraising and bingo shifts going forward.
