- c. SWEETHEART UPDATE Had first meeting on Monday October 24th. Meeting went well. Everyone showed up. See report for information. Met with Joline to discuss budget.

Voting Item: The Sweetheart Gaming & Licensing committee would like to run a pre sweetheart 50/50 draw through raffle box with the purpose of using some of the revenues to purchase a merchant terminal for the raffle table (instead of using borrowed iPads.) Early estimates on cost for a merchant terminal is \$~400. This will better allow us to organize and reconcile tickets/run the squares better.

Raelynn makes a motion to purchase a terminal which would include an iPad and merchant stand for approx \$400.

d. BINGO DISCUSSION - We were issued a penalty for a volunteer storming out of the hall as they thought they could switch half way thru the event with their spouse, however, this was not communicated with me and it clearly states on the sign up that "you must fulfil your shift or contact the bingo coordinator". So because they left I was short a volunteer and issued a penalty. Once we have 3 penalties, we lose 3 bingos, and so on. I'm wondering if we are able to implement something to deter this from happening again. Thoughts?!?! Aaron will send an email to Shauna to let her know that the family did not fulfill the mandatory shift requirement and will be

- required to do another shift. If the family did not, they will move into bad standing and will not be allowed to register again.
- e. CONCUSSION DISCUSSION Idea was brought forth to Vicki, that when you follow the concussion protocol, it makes it hard to bring them back with only having 1 practice during the week it could take up to 3 weeks to come back. Asking if these players can participate in another practice to get back to games quicker. The concern is when a player has to participate in the contact practice before a game. Steps 2, 3, 4 rely on parents. We rely on the doctors note to move to stage 5, have 1 hard practice with own team before game play. This could be looked at case by case. Player must be cleared by own head coach. This will go to division director and 2 others.
