make final decision on whether to purchase a set of boards for SARA

8.0 Executive Reports

- President Kristen Bodnarcuk
 - 2019/2020 good start, several new members on board
 - Developed new policies and enhanced existing policies
 - Implementation of comprehensive plan to attract, develop and retain goalies, included discounting training for U12-U19 goalies, partial discounts U14-U19 goalies and equipment loans
 - U10 Step 1 started RAB initiative half ice games, feedback was mainly positive, will be expanding ½ ice to Step 2
 - Report will be posted on Meetings page, includes links to RAB's website for discussion on Children's Ringette
 - Turkey Ring success again, raised over \$43k for the Association, thanks to Debbie STahn and volunteer committees
 - RAB hosted an Excellence Ringette meeting in November, attended by members of Board and Coaches, feedback brought back to Board, in May RAB introduced 2 initiatives for AA; report will have links to the program
 - Coaches survey revamped to target the players, easier to understand
 - Were planning on hosting U12A Black Championships, work of committee was appreciated even though season ended early
 - Season cut short by COVID-19, heart goes out to players, coaches, parents who were looking
 forward to participating in provincial and national events; other personal impacts in school and
 other things impacted by the pandemic; if people require Mental Health supports encourage to
 seek out and will have those links on the report
 - Thanks to the Board, never expected such an end to the season, many had to stay on until the AGM to continue duties

• Vice President – Tricia Smith

- Turkey Ring, 1000 athletes, 70 teams, many SARA teams who medaled at tournaments
- No discipline related issues
- Bulk of Dibs opportunities is during Evaluations, generally pretty consistent numbers across the events

Registrar – Sandy Michaelchuk

- Had 463 players; 54 Active Start majority of players returned for both sessions; U10 124 players, 11 teams (49 Step 1, 75 Step 2&3); 58 in U12, 54 in U14, 43 in U16, 46 in U19, 84 Open; good strong numbers overall
- 1 less Open team this year, lots of player retention this year
- 8 players transferred out to other associations
- Challenges this year, those U10 numbers grew during the evaluation process so were challenged
 to find teams for all players and coordinators did well finding places; U19 lost 5 players late in
 process so that was a challenge as well

• Treasurer – Scott Petter

- Profit/Loss about a 4 page document so consolidated to a 1-pager to highlight broad categories, the asterisks down the middle are the areas that had the most impact in changes year to year, thought would focus on those as impacted income the most
 - o Gaming Income and Oil Kings 50/50 had in 2018 that didn't have this year
 - o Ice sales down about \$13k, no sales to Black Gold, and no sales for Provincials
 - o Tournament Revenue is Western's Revenue that came in after year end
 - Registration income shows down \$13k, part is due because no Open C team so that is about \$7k in registration; I also realized I accounted for it a bit different than previous Treasurer, my dollars are net dollars, previous was gross dollars, subtraction of credit card fees
 - Recoveries Income coincides with Ice Levy this year, to charge more to the teams that use extra ice and get full ice practices
 - Amortization to \$0 from \$23k, reflects change from previous treasurer who determined
 we don't amortize but instead expense them in year purchased, which is why Equipment
 Expense is a bit higher because of pants order; Jersey's we are 6-7 year mark for jersey's
 so over next 2-3 years will start a staggered replacement of jerseys, will evaluate for
 each age level and have plan to replace
 - Ice Rental is our biggest expense down \$30k, \$15k was due to loss of CAC ice, the other \$15k is due to lower St.Albert Ice use, part due to no provincials or post season tournaments and some cancelled in March as season cut short
 - Turkey Ring expenses, Deb has done a fantastic job, this year we made a bit more because expenses cut by about \$10k
 - Healthy financial position to prepare for future expenses such as jersey purchase
 - Next year will be impacted whether we host provincials or post season play, registration and whether our season is cut short

- Our costs are variable versus fixed, the fewer teams we have the lower our expenses, good position going forward to manage a drop in registration (if that happens)
- Will provide full income statement so it can be posted on website, if anyone has questions about specific things you are welcome to email me at treasurer@stalbertringette.com

- Ice Allocator Sarah Kosloski
 - Busy year, faced a challenge losing CAC ice at start of the year
 - Development 29 hours
 - Conditioning 18 hours
 - Evaluations 43.5 hours
 - Game ice 309.75 hours
 - U10 playoffs and wrap up 3.5 hours
 - Practice 729 hours
 - Playdowns and Provincials & AWG 33 hours
 - NRL hosted games 8 hours
 - Returned and unused 297.25 hours
 - We were able to return ice that was unused due to COVID and the city did not charge us for that

Development – Erik Houde

- AA coach selection May 19, close June 1, interviews and selection committee selected coaches (Eric Lavoy for U19AA, Joel Lajoie for U16AA, and Darcy Owen U14AA)
- Coach selection for U10-U19, application deadline was September 2, received 38 applications;
 30 teams from U10 Step 1 to U19AA and Open, with a total of 186 hard carded Head Coaches,
 Assistant Coaches, Managers, On Ice Assistants, Trainers and Junior Coaches
- SARA hosted a CSI clinic on October 20 and a CI clinic on Nov 8-10th
- U10 Coach and Manager meeting October 1, significant year for U10
- Hosted coach mentor night December 19, 5 SARA coaches to lead some small group discussions, was well received, 30 coaches participated and were provided with practice plans and drills from the 5 mentor coaches

• Evaluation – Lawnie MacDonald

- Report will be on website
- Evaluator costs approx. \$4k
- Review of number of teams at each age level

- Overall the team formation was fairly straight forward, few issues fluctuating numbers at U19 and U19A decision was influenced based on team formation at BGL
- Lack of goalies, half time goal at U14C so used affiliate
- Lost a U16 goalie but import goalie came to association and filled that void
- Struggled with lack of evaluators
- One age group had to deal with some respect issues, in how parents brought forward issues to directors both at age group and evaluations; U12 had issue with buzzers, was some miscommunication, going forward will look to address

Sponsorship/Fundraising – Luke Fevin

- Start by acknowledging work of Jenn Tosto previous year, especially with Westside Acura, money
 in fundraising but also for active start jerseys, thank to them for generous support and to Source
 for Sports for the pricing support
- Annual Raffle is second largest fundraiser after Turkey Ring, review of cost and profit of raffle

Ref Allocator – Sandra Fenton

- Turkey Ring 43 officials used for 122 games
- Did not add any new officials to SARA for the season due to changes with Children's Ringette Step 1 teams playing 3v3
- All officials received at least 1 evaluation
- NARRA changed development program resulting in an association based approach taken
- 3 officials selected for U12 championships
- 9 officials selected for provincials but 4 declined due to scheduling conflicts
- Established a U10 Step 1 mentoring program
- Do no recommend any officials be added due to Step 2 moving to 3v3; but have also learned no level 1 clinics will be offered this season so will not be an option anyway
- Have 4 individuals recommending to proceed to Level 2

Questions from Floor

- Why are we not bringing in new refs, some existing have jobs so might not be available?
 - Sandra: Won't be a decision we can make, if no Level 1 clinics offered cannot bring in new officials; Level 1 is entry level for official (not related to age group)

11.0 Communication

 Jenn Tosto – thanks to Source for Sports, sponsor monthly social media giveaways which has helped grow social media platform

12.0 New Business Items

- Turkey Ring will not be hosted in October; potential dates in December TBD; have been on several RAB meetings, message has consistently been that tournaments prior to Christmas should consider postponing, in May Board meeting difficult decision made to postpone, hopeful will be able to proceed in some fashion in December
- Ringette Canada and Ringette Alberta Return to play plan
 - on July 6 Ringette Canada released National Direction, can be found on website under COVID resource hub, encourage to review, will give a glimpse into direction for return to play

- last night RAB presented beginning of return to play, associations provided feedback, committed to working hard over coming months to keep athletes happy and healthy, will share in a timely manner once we have a path forward
- at this time, I know it's hard to be patient, no one has navigated through this before, from Ringette Canada down to our association we are all working hard to get our kids back on the ice

Question from floor:

- Leduc and Edmonton are running camps, is that an option for us?
 - Kristen: Currently although Ringette Canada has lifted ban on sanctioned events,
 RAB has not; there might be some associations that are taking registrations in hopes
 to run the events in the event the restrictions are lifted; yesterday we received email
 (as a parent) saying SAYSA will not be going ahead; as for planning a pre-season
 camp that is something Board will have to discuss
- I realize unchartered territory so thank you to the Board, I know we are all wondering what
 RAB is thinking. Is there an opportunity for David to answer some questions in this meeting?
 - Tricia: we hadn't put in agenda specifically, a lot of decisions for RAB have not been finalized, but Dave can answer question
 - David: (added in chat) will not be answering questions regarding Return to Play this year
- Will return to play be based on Alberta Health guidelines? From what I understand there are concerns about athletes playing more than one sport so athletes will now need to make a decision and that decision will be based on what return to play is, encourage you to make decision quickly so athletes will know which way they will go. I would hope we would do what is similar across Canada.
 - Kristen: RAB has been working hand in hand with AHS, last night there were some question needed clarification and they were willing to go and get that clarification; will be based on all those things, will be in contact with associations around us to see what they are doing, and perhaps outside of Ringette as well what is good for everyone in our community and all of our sports groups; my understanding is that athletes will have to make a hard decision because you have to belong to a cohort and cannot belong to two sport cohorts
 - Tricia: important conversation but new Board needs opportunity to meet and discuss along with guidelines, these are hard times, and I know many players want to get back on the ice as do I as a coach, need to let the new Board have a chance to make decisions and communication so we don't have speculation; need to give Board time to put the plan together
 - David: (via chat) Our plan will be release ASAP. All sports in Alberta must follow AHS guidelines. We do not have the choice of doing the same as the other provinces unless their health guidelines are the same as Alberta's
- Two children who play multi-sport, hockey, lacrosse, volleyball, from what I have seen in other associations, I don't believe any other sports associations are saying you have to choose a sport, yes you have to be part of a cohort but haven't indicated have to choose just one; hockey has camps and super league has had some tournaments; there have been things happening in other associations and things happening on ice, cannot be an all or none

scenario, not something that can be controlled, if school sports will be happening that will factor into that too

- Sandra Fenton: (via chat) Alberta government released their update on July 20 and it states one sport cohort
- David Myers: couple things quickly to put to bed so can get through agenda, almost at end of planning document, waiting for final feedback from associations, probably a week to 10 days, in the meantime please go to Alberta Biz-Connect (https://www.alberta.ca/biz-connect.aspx) can see all the guidelines; two scenarios, can participate if can physically distance, or have to be in a cohort, if in a cohort have to have 2 week break between cohorts, or they need to be physically distancing; we cannot control what other organizations are doing and one of the ones mentioned is a private organization, I do know that some private organizations are under investigation by Alberta Health; please be patient while we finalize the RAB document
