Required Information:

The Association will collect, store, use and disclose this information about you for the following purposes:

- To enable us ("us " defined as representatives of the SCMBA) to contact you;
- To enable us to respond to requests & complaints from our members;
- To provide information/timing on games, practices, team photo shoots, and fundraisers;
- To allow us to maintain communication with you to distribute information pertinent to membership, player registration, try-outs, and general association business;
- To inform you of any baseball camps, clinics and children's programs that the board deems of benefit to association members;
- To advise you of any changes to our association bylaws, board structure, and board membership;

- To advise you of the date of the SCMBA Annual General Meeting or any other meeting of members;
- To ensure our coaches understand, and can assist in supporting any material medical issues;
- To collect unpaid registrations and accounts and to invoice for goods & services rendered by the SCMBA;
- To prove age eligibility for players;
- To be compliant with the requirements of the Ontario Baseball Association Inc., Central Ontario Baseball Association, Select Ontario Baseball Association, Niagara District Baseball Association, and any baseball governing bodies under which SCMBA operates;
- To distribute association sponsor news, deemed of benefit to association members by the board;
- To provide an informed baseball experience for all players and families.

On behalf of myself and the player being registered, I recognize that baseball entails serious risks. Consequently, except as noted below, I and the player being registered relinquish all rights to a claim of any kind, including the right to a claim for bodily and material damages, regardless of the cause, against Baseball Ontario, its member associations, including **ST.CATHARINES MINOR BASEBALL ASSOCIATION** and their respective officers, employees, coaches, umpires, assignees, agents, representatives, and sponsors, even if such damages result from negligence of Baseball Ontario, its member associations, including **ST.CATHARINES MINOR BASEBALL ASSOCIATION** and their respective officers, employees, coaches, umpires, assignees, agents, representatives, and sponsors.

Without restricting the generality of the preceding, I and the player being registered also relinquish the right to any claim against Baseball Ontario, its member associations, including **ST.CATHARINES MINOR BASEBALL ASSOCIATION** and their respective officers, employees, coaches, umpires, assignees, agents, representatives, and sponsors resulting from a decision on their part, regardless of

the nature of this decision.

This release of Baseball Ontario, **ST.CATHARINES MINOR BASEBALL ASSOCIATION** and the other persons noted above does not preclude myself or the player being registered from making a claim under any sports accident coverage provided by Baseball Ontario and/or **ST.CATHARINES MINOR BASEBALL ASSOCIATION** to their players.

ROWAN'S LAW COMPLIANCE

Under Rowan's Law, before any player can be registered with **ST.CATHARINES MINOR BASEBALL ASSOCIATION** and Baseball Ontario, the player, and the parent or legal guardian of the player if the player is under 18 years of age, must review one of the Concussion Education Resources provided by the Province of Ontario and must review the Player Code of Conduct.
