- 1) Call Meeting to Order (Clint) at 7:32 pm.
- 2) Softball Presidents Report (Sarah)
  - a. Sarah touched base on the softball season for all teams. Overall a great season for softball.
  - b. Discussion regarding the evaluation process for team selection needs to be made clearer.
  - c. Discussion with regards to having registration done earlier.
  - d. Discussion regarding a U8 program for next year. Softball Alberta is implementing a U8 program next year.
