- 2) Treasurer's Report - Janelle
  - a. Current Account balances are: Casino -\$1,716.38, General -\$44,977.18

### 3) Registration - Danielle

- a. Danielle gave an update for both softball and baseball registrations. ### 4) Casino / Raffle - Lisa via email

- c. Cash raffle - further discussion in March. We will need to choose the prize amounts and can figure out ticket numbers from there. Options include \$5,000, \$2500 and \$1000. There are requirements for the amount of ticket sales versus prize amount. A lower option could be \$2500, \$1000 and \$500 prizes.

- b. Sarah has started accepting tournament entries for the girl's tournament this summer which will be the first weekend in June.
