- 1) Call Meeting to Order (Clint) at 6:01pm. Meeting was held via zoom ap.
- 2) Return to Baseball/ Softball
 - a. Changes were minimal from previous restrictions for both baseball and softball.
 - b. Discussion regarding restrictions possibly being lifted on March 22.
 - c. SMBA plans to have try outs for the week of March 22nd for baseball.
- 3) Booking Rec Center
 - a. Sarah has dates booked for the rec center Tuesday & Thursday nights from 5:30 to 9:00, starting March 16th for softball. Softball dates are March 16, 18, 30, April 1, 6, 8.
 - b. Baseball is booked March 22 to 27th for baseball try outs.
 - c. Sarah also noted we have to do registrations because we cannot do drop ins. Charge of \$10/night for skills.
 - d. Stetter Rec Center would like 3 days notice for cancellation.

- 4) Registration
 - a. Discussion on current registration numbers which have increased since our last meeting. Coaches registrations are also needed.
- 5) Apparel
 - a. Wendy, Kathy and Michelle Went over current inventory.
 - b. Wendy brought forward setting up a table during tryouts (outside of the building).
 - c. Michelle is going through jerseys to get an inventory.
- 6) Fundraising
 - a. Lisa looked into the raffle box fundraiser which looks great. There would be a webpage set up for our SMBA. You can select the player that you are supporting. Tickets are auto generated. There is an email sent to the player once a ticket is bought from them. There is also real time update, so you always know where you are for ticket sales. You can also have it linked to the rec center etc to see on big screen. Fee is 10% (7% to raffle box, 3% to strike connect). We would get the raffle license and supply raffle box with our logo.
 - b. Jerilyne made a motion to go ahead and use raffle box for a 50/50 raffle this year to be completed before June 1, with the possibility of a second raffle. Wendy second, all in favour, motion carried. Lisa will contact raffle box and AGLC to set up.
 - c. Lisa is also looking into a government grant. Lisa requested further information to complete the government grant and will have it emailed in before March 12th.
