- **4.1** What does the remainder of the season look like for SMHA There was lengthy discussion in regards to the recent update from the Alberta Government regarding the COVID-19 mandatory restrictions in place, as well as the statement issued from Hockey Alberta, and how this affects our players. The board discussed what the options would be if given then green light to be back on the ice March 01, 2021; the Stettler Rec Center would be open to the possibility of extending the hockey season by one month.

Allison made a motion to end the regular 2020/2021 season effective immediately, and re-evaluate the options if/when the restrictions are lifted. All in favor.

Due to the decision to end the hockey season, the Ref / Ice Allocator position will be done for the 2020/2021 season, effective February 01, 2021.

**5. Old Business** - **Refunds for the remainder of season** – It was decided at the last meeting the final payment for the season would be deferred until February 28, 2021. As it has now been decided to end the current season, there was a lot of discussion in regards to how these refunds will be handled; what formula will be used to come up with the most fair number, and how HA and CAHL will handle their portion of the fees. The board will discuss the findings by February 18<sup>th</sup> in order to have the refund figures by February 28<sup>th</sup>; this will allow Martyne the 1 week she needs to process the refunds.
