We struggled again this season with team sizing in some divisions, to big for 1 not enough for 2. We oversized our U15 Females as we had some Stettler players released from AA tryouts that needed a home. We had enough players this season for 2 U15 and 2 U18 teams which is more then in past years. Hopefully we see this trend next season continue.

I would like to thank Stephanie Hadley from ACAA who had our board sit in and help with a SWAT analysis and discuss a presentation for all age groups to participate in. This presentation (conversation) would be with team leadership and players focused on recognizing signs of abuse, harassment, and online exploitation. This conversation will invite all participants to ask questions, share concerns and learn about how to support each other. This past season we had 1 team sit in on the presentation and hopefully for the 2023-24 season all teams can have the opportunity.

Senior Ref numbers continue to decrease all over Alberta, and we are feeling it in our association. U15/U18 Tournaments are a huge concern needing to outsource refs in order to make it successful. Therefore, the board did vote on eliminating these tournaments from the 2023-24 season and see if that helps our association, Refs and Ice Availability.

This season had many of its own hurdles that didn't happen on the ice. The 7 Executive members- have spend hundreds of hours solving issues behind the scenes this year. It has become more difficult to put hours into our elected positions to make the association stronger when constantly sitting in meetings/discussions making decisions that we feel are best suited of our association and all of its members. I cannot thank Kelsie, Martyne, Jace, Reid, Sarah, and Trevor enough for all their time this season.

A summary of this year's events are as follows:

SMHA once again offered skill development sessions starting the last two weeks of August and working through September including: Val Norrie, Cross Ice power skating, Girls Weekend, and Stable In The Net goalie development. SMHA also offered two weeks of off Cross Ice Development and In House on ice skill development skates ran by are SMHA coaches, We also were able to run a Pre Checking Skills skate for are first year U15 kids which was also ran by Cross Ice Developments in which some SMHA coaches attended. In addition to the development for older players, SMHA offered power skating with Ashley Grantham for our U9 players with two sessions ran through out the year.

Due to the growing success and interest of the "PD Day" skill development sessions ran by Cross Ice Developments we were able to run multiple skates through out the year along with a second goalie development skate at the start of teams' playoff runs which was also put on by Stable In The Net and well attended. With the growing interest in our skill skates, we opened are second PD skate to our U9 players and were able to run four groups of kids through out the day.

As far as SMHA Coach developments our reviews of our coaches were for the most part positive. 98% of negative reviews were based on coaches lack of discipling players when needed and taking part in disrespectful or inappropriate behavior themselves. With a few concerns over kids development due to practice and skill planning. It's a very thin line in this demanding sport to be a competitive, fair, and successful coach but the most important I believe is having good communication between your players and parents explaining your actions and thought process thought the year. Some of are best coaches in SMHA are the kindest. Be a good role model and your players will follow. Overall, I thought SMHA had a very positive year with some great runs in playoffs and Provincials. SMHA will continue to work to provide these opportunities in the future.

U7 Division Report 2022/2023- Submitted by Brook Watson Another successful season for the U7 boys and girls. The division had small enrollment numbers; we opened the registration again. Doing this we gained one additional player from a different zone that was unable to form a team for their area. Still running with small numbers (34 players) the decision was made to continue with 4 small teams (2X 9players, 2X 8 Players) rather than 3 large, these were created in Early November. The advantage was the kids all got ample ice time; it made scheduling in-house games seamless. A disadvantage was when kids were absent for game nights. Although Coaches and players managed to adapt and switch players if needed to try and keep the 4 vs 4.

Ice times, the practices ran 4:15pm-5pm (45 mins). Games Started the last week of November on Fridays from 5:15-6pm, we scaled back game times to 45 mins from 1 hour. This was to help with limited Ice availability for SMHA in addition to helping the coaches get from u7 to u9 immediately after and overall, well received from U7 players and Families.

Managers were selected based off interest in the position and at the discretion of the Director, most of which were successful in this. Suggest keeping management positions at the director's discretion.

Coaches, with a total of 14 mostly everyone stepped up, stuck to a schedule provided by the onice coordinator, and covered each other when required. Two newer coaches obtained Level 1 and Safety certificates as well. With a few select parents always willing to offer a helping hand when they could; to set up and take down equipment for games and practices.

The Director booked each team into one away tournament, 1 team in Castor (December) 1 team in Hanna (Early February), 2 teams to Big Valley (End of February). Castor and Hanna run with a 2-game day; Big Valley run with 3 games. Would recommend trying to find tournaments with only 2 games, 3 is a lot for the players. All these tournaments were confirmed early in the season to ensure proximity to our hometown. If a team was short a player or two, they managed to pick up additional coverage from a non-playing team without issue.

Our home Tournament was on February 11th we condensed down to 3 teams for the tournament, invited 3 out of town teams for a total of 6 teams. It was a smaller tournament with each team playing 2 games. Would recommend 6-8 teams total for



the home tournament. The Tournament brought in \$2,241.40 profit and positive feedback from all.

Overall, the season wrapped up on February 27th with a gathering in the Studio room at the Rec center. First year playing kids awarded First Goal Trophies second year players presented with personalized

engraved hockey pucks. Every player received recognition for their involvement through the season whether it was MVP, Heart & Hustle from tournaments or a medal in house.

The U7 Tournament account had a balance of \$2,848.15 in September 2022. Closing March 2023 with a Balance of \$3,011.30. This will be carried over to help with the next season and paying entries to away tournaments and team building. All which costs seem to be increasing.

Here is to a great season with wonderful, players, parents, and coaches.

### **Tournament**

SMHA U9 tournament had 18 teams on Blue ice. Fun hockey had 4 teams on red ice. Both set up raffle tables in the lobby. We worked with Center Ice to provide hot dogs, a snack and a juice box to every player using coupons at a tournament cost of \$5/player. Center Ice did their best business of the year during our tournament and will be offering this option to future tournaments.

The Tournament, as a whole, went well. Many compliments. Tournament has a net income of \$7200 after SMHA payment and an estimated ice fee.

### **Tournament Proceeds**

U9 will be refunding all its cash calls this year and will be left with a net profit of \$2700 pending a final reconciliation. In speaking with Joel, he and I both intend to be back next year for U9 and we'd like to make strategic choices with the money we've raised. Our goal would be to purchase equipment or training that will benefit the program in the long run. Is there any issue with us spending this money over the summer?

### **Wrap Up**

We had our year end party after our Saturday morning skates at the end of February. We ordered 200 blokes donuts, got 100 juice boxes, and Centre Ice donated coffee. We encouraged all parents and siblings to come up to the meeting room and join and they almost did get through all the donuts! 170 would have been the perfect amount but we sent extras home with our SMHA families to power up their big kids who played later in the day.

As this year has wrapped up we have begun to think of next year.

### **Travel Team**

In speaking to parents, there is still a lot of interest in a travel team. While the last 2 years have been unsuccessful, we believe some of this is due to communication methods (I sent emails from my personal email this year and they went to junk) and the pandemic. Depending on registration numbers next year, we'd like to table this in September.

### **Girls Tournament**

A few girl moms have approached me about taking our girls as a team on the road to one all girls tournament next year. If done, this would need to be equitable to all



genders playing hockey. It could also only be done if there is NO travel team. I feel we can run an inter-house tournament for our boys on the same weekend the girls are away. We would need to disperse players to make 4 teams and they could play for a candy cup (can we score keep?). This can be tabled till September as well.

### **Away Tournaments**

Feedback has been that families want an opportunity to play two away tournaments. We recommend for the 23/24 season that teams that decide to pursue two tournaments next year would have an increased cash call and the decision and booking of the tournaments would need to be done by a certain deadline. We would require the manager to take a vote with 90% agreement for the team to attend a second tournament.

This year we had 33 kids try out for two teams. 17 on the A team, 18 on the B team. Two players were late registries that did not try out (went to the B team), with a third having to be turned away for full rosters.

Our A team played tier one in CAHL, finishing second in the regular season. They played RMAA in the first round of playoffs and lost to them in the second game. Playoffs were played in a best of three game format. U18 A attended two away tournaments, one in Cochrane, and one in St. Paul.

Our B team played tier three in CAHL, finishing third place after the regular season. They played Red Deer in the first round of playoffs, and beat them out in the second game. In the second round they faced Drumheller and lost after the third game. Playoffs were played in a best of three game format. U18 B also attended two away tournaments. One in Sundre and one in Calgary.

Both teams hosted a tournament together, bringing in six other teams. This was a four team per division round robin style tournament. Each team played three round robin games, with the fourth game being either gold/silver or the bronze medal game. Stettler A won gold in their division, and Stettler B won silver in their division. The U18 division had difficulties fielding referees for their home tournament this year for two reasons; lack of available refs for the age group, and ref's not wanting to ref U18 games for poor sportsmanship by the players.

This season our U18 division had several issues with discipline (players and parents), resulting in practice and game suspensions, as well as one player being suspended for the remainder of the season. Policies are being reviewed and updated to support these issues in the future.

U15 - Ended season early. Started with over sized roster had 2 players quit due to coaching issues that could not be resolved. One coach suspended.

U18 - Finished the season runner up in the league final. Won silver medal in the U18 A Provincial Tournament.

RMFHL Update:

SMHA Female Director is the ONLY person who is to contact the league.

League will work with CAHL next year with booking ice.

Fine for tournaments during tiering.

Ice schedulers to use one email next season to prevent confusion.

Going to RAMP for website.

1 female staff must be on the roster.

Game Misconducts are to go to president right after the game.

Over Aged Players must be marked on all game sheets. Max of 4 that are 1 year over with application approval by the league and Hockey Alberta.

Penalty Box Workers are considered to be off ice officials. Team Jerseys cannot be worn by workers in the penalty box.





12 players needed to start a game. Affiliates to be listed at the start of the year. Affiliate goalies can only be used if a player is injured with special permission.

Challenges for the season brought forth by SMHA members:

**Unfair ice times** - solution for the future SMHA to adopt fair play rule to coincide with Hockey Alberta's LTPD plan. [Long-Term Player Development | Hockey Alberta](#) To have 55 and 5 rule other associations are going to this policy to support the LTPD and mental health and retention of minor athletes. Where lines are rolled for 55 minutes of the play and coaches get 5 minutes of play to make bench changes which shorten the bench for power play opportunities, etc. Suggestion by RMFHL.

**Unapproachable coaches** - solution for the future disciplinary committee to provide feed back and support to move forward. SMHA adopt more concrete disciplinary measures for future issues.

**Dressing Room Supervision** - Solution for the future to have strict policies in place that a legal aged coach must be present at **all times** in the dressing room. No cell phones.

**Affiliated Players**- Not all players are getting the opportunity to affiliate. Solution for the future to ask all players who would like to be affiliated. We can accommodate a larger affiliation roster.
