**1. Meeting Called to Order:** 6:03pm

**2. Additions / Deletions to the Agenda:** No new additions or deletions.

*Melissa Muise motioned to approve the January 08, 2026 meeting agenda. Matt Fryer seconded the motion. All in favor.*

**3. Review of Last Month Meeting Minutes:** Reviewed the December 02, 2025 meeting minutes and action items.

**4. New Business**

**4.1 Review of Mid-Season Reviews** – We had a great response rate this season, well above previous years. Chelsey put together a slideshow with the data collected and the main take-aways from the reviews were discussed, overall, reviews were positive. Coaches and managers were sent a scorecard with a summary of their review, both positive & negative. Reid and Joel will reach out to coaches to discuss



any concerns. SMHA families will receive a general summary of the reviews, as well as a reminder of the proper chain of communication.

**4.2 Christmas Ice Schedule Feed back** – Unfortunately, not a lot of the ice was utilized over the Christmas break. Next season we will have some ice available during the week of Christmas break and will offer it to teams that have games/tournaments scheduled over the weekend.

**4.3 Update on Practice Jerseys & Larger U9 Jerseys** – The U9 jerseys are being used and fit well. Discussed where they will be stored, and how to keep them separate from the other jerseys.

**Action Item:** *Reid will talk to Joel and sort out where these jerseys are being stored.*

**4.4 Female Banquet** – Melissa has the Hub booked for the Female banquet, February 06, 2026. It is currently booked under Len but switch the booking into SMHA to help save on the cost. Melissa is requesting \$2500 from SMHA help with costs for this event and will provide a detailed breakdown of how the funds will be spent. Melissa will also compile a list of volunteers needed, which she will provide to Chelsey as opportunities for SMHA families still in need of fulfilling volunteer hours.

*Brett Muhlbach made a motion to spend up to \$2500 for the Female division to host a banquet. Matt Fryer seconded the motion. All in favor.*

**4.5 Power Skating** – MVMT Training & Performance reached out to SMHA to offer their power skating services. Any team(s) that are interested in booking a session are welcome to do so, each team will be responsible to cover their own costs. The board will look into offering power skating sessions for teams for the upcoming season. Power Skating information is attached below.

**4.6 U7 / U9 Ice** – Discussed allowing U7 to keep their Tuesday practices until the end of February, but will need to give up their Friday ice following the Family Day weekend. The U9's are able to keep their Monday & Wednesday ice until the end of February.



**4.7 Oilers Game Update** – SMHA sold about 60 tickets for the Oilers game. An email will be sent out with the details for those players who will be taking part in the High Five line.

**4.8 Jersey Replacement:** SMHA needs to start thinking about replacing the team jerseys, as there are many that have already required repairs. We will table the discussion to a later date but will start to collect some information on possible jersey options. Also discussed the possibility, if we are replacing jerseys, of changing the Stettler Storm logo and what a rebrand might look like.

**Action Item:** *Kendice will talk to her sister, who works at a sports store, to find out which jerseys are the best quality, as well as an idea of tentative costs.*

**4.9 Coaches Manual:** Brett has been working on putting together a manual to provide to all coaches at the start of the season. He has presented a draft to the board, as well as a few fellow coaches, and is looking for any constructive feedback on whether or not this would be something coaches will use, and if it is something he should continue to develop. It was discussed that this shows the desire to help develop coaches and that it would be a benefit for SMHA to be able to provide these to their coaches.

**4.10 Coaches Game Book:** Brett provided an example of a small game book that coaches could use on the bench, instead of having to use binders and looseleaf.

*Kendice Stenlund motioned to spend up to \$150 and have 5 Game books made and given to a few select coaches to trial using. Ruby MacDonell seconded the motion. All in favor.*
