## **Treasurer Report**

- About \$34000 in bank right now
- No expected costs to decrease that (some ref cheques need to be cashed) Some money would be used for COVID discounts
- Has old cheques, and old stamp asked to destroy all in favour of destruction
- Not accepting registration money until at least Sept to limit refunds when the time comes
- Encourage to register but not pay
- Teri motions to accept, Rebecca S seconded. motion carried

## WRRA - Zoom Conference

- WRRA was happy with SMRA that we have good position with where we are with money for refunds ECT
- Recommending holding off on accepting money to limits refunds
- Opportunity to move tournaments, some associations will need to due to money, we will likely not fall into that category
- Rebecca S asked about extending the season, but not sure how that would be feasible due to other sports that have also lost on their seasons, have to remember about municipality being left in and extra costs involves with that
- WRRA impressed with how SMRA is sitting with money and registrations that we already have, leaving us sitting in a good spot

  - IDEA: having a high schooler do this for community service hours (recommendation from RO, could be changed as the town or the health unit could take that over)
