Evaluators are to follow the supplied evaluation sheet. Data will be entered into the Strathmore Venom evaluation database to determine placement of players.

Disclaimers

- All athletes must be evaluated at a MINIMUM of 1 floor time. If not, the athlete will be placed on the C team / Division 3 team.
- The club will do our best to honor special requests during the evaluation program. These special requests from U7 and up will be limited to family relations (siblings) on the same team. If one sibling is on B, and one on C, the B player will be mandated to play C if the request must be met. Physical/ Safety requests due to physical size (ability to get approval from CDLA to change age groups), along with mental health considerations. However, the Club will not be committed to meeting all requests. We ask that all requests be submitted Prior to the evaluation floor times. Any requests that are post evaluations will not be taken into consideration. Teams are made immediately following the evaluation process, once rosters are released they are final. *The Strathmore Venom cannot guarantee that all requests will be met. *
- Regardless of prior season player placement, each player is eligible to be placed at either B or C and it is completely based on this current season's evaluation.
- New to the 2025 season there will be no parents available to watch the evaluation floor times. Viewing areas will be blocked off for evaluators only. We ask parents to please respect this and allow athletes to perform in a lower stress environment with less viewership to help build confidence and ensure the player is able to preform to the best of their capabilities.
