- 1. Approval of Regular Meeting Agenda made by Jon. Second by Andrea. All in favor. Motion carried.

3. CDLA/ALA Update

- Lacrosse Canada is expected to implement a fee increase for the upcoming season. Increase for the 2026 Box Season is \$15 per player to \$30 per player. The ALA voted for the following increase, we will know after the AGM this coming weekend if it passed.
