Due to the rising costs of ice in the city of Swift Current, player and coach fees to SHA, administration, and in order to cover our block ice with a non cancellation policy, I am proposing that the board approve the following registration fee increase for the year of 2022-2023. U7

(Initiation) from \$450 per player to \$480 per player. U9 (Novice) from \$450 per player to \$480 per player. U11 (Atom) from \$660 per player to \$710 per player. U13 (PeeWee) from \$710 per player to \$790 per player. U15 (Bantam) from \$710 per player to \$790 per player. U18 (Midget) from \$710 per player to \$790 per player. These fees include AA as well unless we want to discuss that. The AAA costs will remain the same at \$1000 per player for this season. I'd like to also propose to waive paying tournament fees, instead we can issue "Loans" to cover upfront costs of tournaments with the understanding that all "loans" are to be paid back in full by November 30th. Registration dates are set for May 1st, 2022 with a deadline of August 15th.
