5. Old Business:

President Brad Torry updated the Board on the issue of Net moving and pegging during scheduled games and S3 & Innovationplex. The City of Swift Current Department of Recreation have advised us that if we want the City employees to move nets during games they would have to dramatically increase the ice rental fee to cover the cost of adding extra employees to move nets and pegging. Paul Hegglin did research on Hockey Canada Insurance Policy, Hockey Sask and Independent Insurance brokers to ascertain the cost of Minor Hockey Covering Volunteers to cover them if there was an injury on ice moving nets. There is No Insurance whatsoever to cover Volunteers who up to this point have been moving nets. No private Insurance would cover these Volunteers. After much discussion, the Board was not willing to pay the City increase costs per game for employees just to move nets.

The following motion was made to rectify the ongoing situation.

The Swift Current on ice officials (Linesman) will be tasked with moving nets during games.

U15 Division and up will be compensated an additional fee of \$20.00 per game.

U11 & U13 Division will be compensated an additional fee of \$10.00 per game.

The funds will come from Home team fees. Tournament Committees are responsible to add these costs during Tournament games.

The referee assignor will indicate which official is responsible for moving nets when assigning games.

Motion was seconded and Carried by the Board.

The U7, U9 & U11 Divisions must have team officials moving nets and Half Ice Boards as they are covered under Hockey Canada Insurance.

**Risk Management/Progressive Discipline Report: Sheldon Paulhus**

**Date: Jan 05<sup>th</sup> 2026**

We received complaints from a U13 team from Outlook , a referee from Cabri, a referee parent from Cabri and Cabri Minor Hockey detailing the U13 Stallions coaches and parents behaviour at a tournament game held in Cabri on December 13, 2025.

The letters accused Stallions head coach of abuse of officials and unruly behavior in the lobby after the game was over. The letters also accused parents making an obscene gesture and comments towards the refs in the aftermath of the game, and kicking and damaging a door and drywall following the game as well.

Head Coach received gross misconduct for his actions from the refs and was suspended 4 games by Hockey Sask.

The discipline committee met and agreed on an additional 3 game suspension for the Head Coach conduct during the aftermath following the game.

Parents involved were given 30 day rink bans for their actions. A parent involved has since apologized to SCMHA , the refs, and Cabri Minor Hockey. Parent has offered to pay for damages incurred.

We also received a letter from a Kincaid Minor Hockey detailing an accusation of derogatory remarks made towards a referee in Kincaid on December 13th, 2025 by someone on the Swift Current U13 Rustlers bench.

The claims, which were made after the game was over (with no official game report to follow by the refs), were not confirmed or corroborated. The Coach claimed he did not say anything derogatory , nor did he hear any such commentary from his bench. With no official game report from the officials , the matter was dropped. The coach was asked to warn his bench that derogatory statements will not be tolerated and come with serious implications.
