**Updates:** Update from SFHL AGM hosted on April 29<sup>th</sup>  
Total of 2122 females registered in the league this year, the number of teams were up but the number of players was similar than last year  
There were 1357 regular season games played, 265 playoff games and there were 51 suspensions handed out this season.  
The SFHL had 637 registered coaches, managers and trainers. Big thanks to all that volunteer their time in female & Co-ed hockey  
For the 2025/2026 season the SFHL plans to roll out a web application interactive calendar-based scheduling tool.

The SFHL is looking to restructure some of their executive committee roles by adding some new positions

1. **Technology & Communications Officer - New Position**
