- 125 Teams in the league this season
- 2216 Female players in the SFHL - 104 more than the previous season
- 681 staff / volunteers
- 1647 league games - 279 playoff games
- 34 suspensions handed out - 51 in the previous season
- Only 4 coaching suspensions
- Lengthily discussion around the creation of an "A" & "B" league. Tabled for now with the idea of creating a committee to properly review.
- Trial next season using the 3-game modified format for the 1<sup>st</sup> two rounds of consolation side playoffs. Congestion of hockey at the beginning of playoffs and this may help communities with ice shortages.
