#### SCMHA Board of Directors

RE: Swift Current Minor Hockey Goalie Coach

- SCMHA to seek out a minor hockey goalie coach (Greg Kleevgard and one or two assistants) with honorariums TBD
- Provide 2 -3 hrs/ 2x a month split between 2-3 groups of goalies from September March
- Break groups into 0.75 1 hr for Novice/Atom, and 0.75 1 hr Pee Wee/Bantam depending on abilities and numbers
- Can use a portion of the ice during practice times when Initiation/Novice have only 1 team on the ice, or a time slot to the goalies themselves (4pm or 6:30 am)
- Benefits will be better instruction than many of our non-goalie coaches can offer, learning fundamentals, basic movements at younger age, consistent messages throughout career resulting in stronger goaltending throughout association for the long term and a continued success of SCMHA teams.
- Families of goalies can receive high quality consistent instruction without leaving town
- Coaches (many of which aren't comfortable coaching goalies) won't need to spend as much time specifically with goalies during practices, and the goalies can practice and work on skills learned from proper coaching. Goalie coach would provide team coaches with summary and basics to keep up the skills learned during goalie practice
- This will save the local goalie coaches from helping goalies on a team by team basis
- SCMHA to cover ice costs, no add'l charge (or minimal) to goalies costs are covered by divisions allowance or a fee increase of \$5-\$10 per SCMHA player. Funds could be taken from teams ice allocation, similar to how we pay for outside power skating instruction
- Out of town goalies could attend if vacancies exist (cost tbd)

This will be implemented and monitored by Gerald. Nola will contact Greg to ascertain ice times. Minor Hockey will attempt to find ice time to use and parents to

pay for the Instructors time by honorarium. Program will be reviewed in the fall by Board.

### 6. New Business

Zone 3 Meeting in Gravelbourg, Sask was attended by President Aaron Bakus. Kelly McClintok asked about the AP system if it should be changed. Aaron showed Kelly our system and that Gull Lake has also adopted our AP system which he thought was very good. Greg Haubrich informed Aaron he will be seeking another term as the Zone 3 Rep for SHA.

Nola informed the Board regarding the ice schedule and that Rep teams usually get 2 practices a week and House League teams get 1 ice team practice per week depending on game schedules. It usually works out but there are times when some teams get more practices than others depending on game schedules and it all works out in the end. It has been difficult to book every team practices during the World Under 17 Tournament and some teams have to go out of town for practices which Minor Hockey has paid for, however this will cease after the World Under 17 Tournament is over. If teams want to book practices out of town they may do so but will be paid from Team fees and not Minor Hockey. Division Heads to inform teams. If there is a discrepancy the Division Head will contact the Ice Scheduler to resolve the issue.

There has been issues with local Equipment suppliers not knowing the proper Rules regarding the Standard Team clothing and Sponsors. This was discussed at length by the Board. The Rules & Regulations will be amended to reflect that Only AAA/AA teams may show team sponsors on team clothing. All house league teams will show the SCMHA Logo only and follow the guidelines set out for team clothing in our Rules & Regulations. Next season the local businesses will supply minor hockey with standardized team clothing and price lists for all they wish to provide and teams can select whoever they wish to provide the clothing as long as it meets the SCMHA guidelines set out in our rules and Regulations. This should alleviate any further discussion regarding what can be purchased and what cannot be purchased.

As SHA has dictated to all Minor Hockey Associations in the Province that AAA Female/Male teams cannot hold Spring camps until after SHA Zone camps which is April 20<sup>th</sup> this puts us having to keep an ice surface open in Swift Current. The City and Minor Hockey have agreed to keep 1 ice surface open as long as SCMHA is willing to use the facility for a minimum of 80hrs. Therefore we must come up with ideas on how to utilize this ice time by as many means as necessary. The Board discussed on how we will accomplish this and utilize the ice to meet the requirement. Further discussion is forthcoming.

Gerald Johnson wanted to discuss the dressing room allocation at the Fairview Arenas as there have been times there are insufficient rooms available to use on weekends. The matter was brought to the attention of the Manager of Arena's Chris Poole and he will instruct his staff to ensure there are sufficient room available for use. It has been trying during the World Under 17 Tournament and so many games being played but this should level out this weekend when the tournament wraps up.
