Mandatory masking by spectators entering any sports facility as well as players, coaches, staff unless on the ice and participating in on ice activities. Coaches must wear masks on the ice and on the bench. At this time no mandatory vaccine passports need to be shown for our Under 18 hockey program. No QR code needs to be scanned. This is an ongoing process and could be amended at any time.

SCMHA will provide helmet stickers to every registered hockey players in SCMHA with a #7 Play for Pey. They will be distributed once available.
