Registration Director Dave Smith informed the board that the Hockey Sask AP form is no longer being utilized. He will add AP's to each team Cert form once Division Heads decide which AP's are to go on which team.

Registration Cert forms for each team must include all information regarding Players, Team officials including HCR numbers and CR/VRC dates. This is mandatory as we no longer utilize Safe Places. The CR/VRC are good for a 3 year period under Hockey Canada.

Releases were also discussed as there is some confusion who is eligible to be released. Any player who attends a AA camp and does not make the local team is allowed to be released to attend another AA camp to the next closest center. Some other associations request immediate releases for these players to attend tryouts. All other releases from other players who are not from our Associations or from our Association wanting to go elsewhere must submit a request to the President of SCMHA who will decide whether to grant a release or not.
