

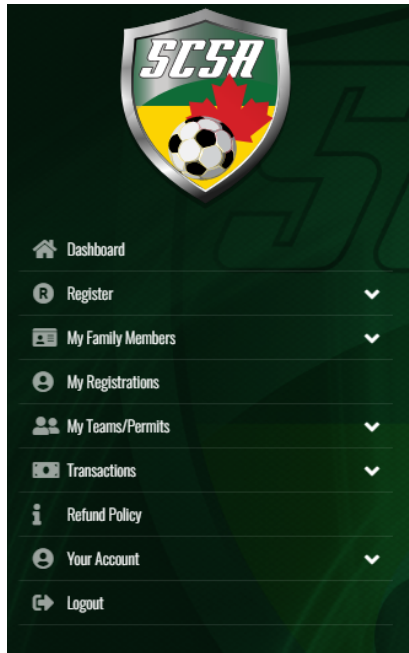

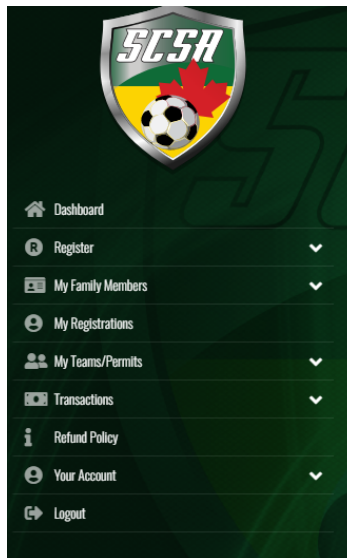

DECLARATION OF COMPLIANCE

A Participant (or the Participant's parent/guardian, if the Participant is under the age of majority) who is unable to agree to the terms outlined in this document is not permitted to participate in the Association's activities, programs, or services at this time.

I, the undersigned being the Participant or the Participant's Parent/Guardian (if the Participant is under the age of majority), hereby acknowledge and agree to the terms outlined in this document:

1. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization and COVID-19 is extremely contagious. The Association may put in place preventative measures to reduce the spread of COVID-19 or any other "communicable diseases, including viruses of all kinds" that requires all participants (or their parent/guardian, when applicable) to adhere to the compliance standards described in this document.
