Field Lacrosse Scorekeeper

Minor Officials Off-Field Quick Reference Guide

Duties:

- 1. The scorekeeper shall accurately record goals scored, assists and penalties.
- 2. The scorekeeper should double check that all the fields are filled out properly on the score sheet. If there are glaring errors, report it to the head referee. It is a good idea to ask the referee for the 'in home' and designated defender (if needed). Put an "IH" and or "DD" beside the player's name.
- 3. The home team is listed on the left of the score sheet and is allocated the left hand bench area when facing the field from the timers table. This makes it easy for everyone. In some high level tournaments, the home team receives the first choice of bench area.
- 4. The scorekeeper shall record the time outs taken by each team. Record the period and time on the clock shown. The time will be given to you by the timekeeper. Inform the Chief Bench Official (CBO) or the referees if a team exceeds the number of time outs taken.
- 5. Time outs are limited to 2 per half and 1 time out per 4 minute over time period. No time outs are allowed in a sudden death overtime period.

Duties:

- 6. When a referee reports a penalty, the scorekeeper records the name and number of each player who is given a penalty. Record the foul, the duration of the penalty and game time on the clock of the penalty from the timekeeper.
- 7. T = Technical's are all 30 seconds long.
 - P = Personals are 1-2 or 3 minutes long.
 - E = Expulsions are 3 minutes long and the "In Home" must serve the penalty.
- 8. Notify the CBO or referees if a player incurs 5 <u>personal</u> fouls. This player is now expelled from the game. Technical fouls are not counted for fouling out.
- 9. If any coach or player receives an expulsion penalty, they must leave the bench area or any area adjacent to the bench. They may return to the spectator side of the field as long as they do not disturb the game.
- 10. At the end of each quarter, the referees and scorekeeper will check to see if they have the same score.

Duties:

11. Standard calling of a penalty from a referee is:

a.	Colour of team	Blue
b.	Number of the player	13

c. Type of foul (also uses signals) Interference

d. Duration of penalty 30 seconds

12. After each quarter, draw a heavy line separating the last goal scored.

13. Sign your name on the score sheet as the Official Scorekeeper.
