- 3.3 TORL Cup: A good discussion was held. Some critical information is missing, so a Committee will be formed to look in to what is allowed.

## 4.0 New Business:

- 4.1 Officials Game Rates: Motion by Cathy, That the Officials Game Rates, for TORL, will be increased by \$5.00 per game, at the U10 through Open divisions. The rates will come into effect Oct 14,2023. 2<sup>nd</sup> by Richard. Abstained Nathan, Cathy, John, Tessa and Tammy. In favour Wayne, Katelyn, Richard and Rosemary. Passed.
- 4.2 Game Sheets- Katelyn: Please make sure Game sheets are filled out properly with all information entered. (IE: Game #, date, division, coaches names, refs names, etc.) Katelyn will be returning games sheets if proper info is not included.

Ramp – Katelyn has done a great job with getting Ramp up and running, she will be sharing resources with the Presidents before entering into Ramp. A suggestion of a Resource Tab for Developmental information be added.

- 4.3 U12 Competition Intro (CI) program. League will manage it. A Reminder that this is not a Zone Program, but it will be a TORL equal teams program. TORL will approve coaching staff and get Procedures from RBC on how the program is to work. Athletes from Salmon Arm and Vernon have already paid a fee, but there is concern that it may not be enough. Once we hear back from RBC we can move forward.
- 4.4 BCWG: Zone 2 does not have a Zone Coordinator. Tessa will chair this position but will NEED a volunteer to do most of the work. Tessa will give guidance to the volunteer .
- 4.5 Game Cancellation: Game Cancellation Policy must be followed. If Presidents can send Tessa a list of contact numbers for each coach/manager of each team she will distribute to teams.
- 4.6 · . PRIORITY Before John can properly do the schedule, he needs teams tournament schedules.
