

TriPort Minor Hockey COVID-19 Safety Plan

1. No person may enter the facility if they have cold or flu symptoms, if they have recently been in contact with anyone suspected to have COVID-19 or similar infectious diseases, or if they have been outside of Canada in the past 14 days.
2. A COVID-19 Ambassador or Communication Officer will be assigned. This volunteer/parent/coach or instructor would oversee adherence to the return to play plan, and ensure COVID-19 protocols are being followed, and would monitor Provincial Sport Organization or League Sport Organization updates.
3. At all times, facility users are expected to keep 2 metre (6ft) distance between themselves and others outside of their household.
4. Players may enter through designated entrances 15 minutes prior to ice time and must leave through designated exits no later than 15 minutes after.
5. Players that need help tying skates must sit on the marked benches in the stands
6. Avoid touching surfaces unnecessarily.
7. Please bring your own labelled water bottle(s) and do not share water bottles with others.
8. No congregation in any of the open spaces including clustering outside the facility entrance or in the parking lot spaces can be permitted.
9. Face coverings are recommended as an additional layer of protection in the 2 metre (6ft) distancing cannot be maintained.
10. No sharing of equipment. Shared training equipment will be sanitized after each use. A sign out sheet will be provided for users to indicate when the equipment is used and to sign off when it has been cleaned.
11. Patrons are expected to wash their hands with soap or sanitizer upon entering the facility and frequently throughout their visit.
12. Please monitor self-care such as hand washing and personal hygiene.
13. Each session will have a maximum of 50 players including coaches, or group representatives on the ice at any time, provided the areas and play are able to facilitate the physical distancing requirements - coaches must be identifiable as a coach, not in full gear, and one must be over the age of 18.
14. Dressing room use will be assigned, and no more than 10 people can be in the dressing room at one time. Players are asked to come with as much gear on as possible.
15. Showers not available at this time.
16. 1 guardian per skater can attend each session.

17. Designated spectators' areas will be assigned for each booking. Spectators are to observe from assigned seating area to facilitate sanitization between each use.
18. No spitting anywhere in the facility or on the ice.
19. To ensure the facility can remain open and safe, please obey all rules as presented by the Municipalities and the Province of BC.

If facility users do not follow the safety regulations and protocols while on Chilton or Cruikshank arena property they will be asked to leave, and their facility usage privileges will be suspended.

Additionally, upon registration, you will agree to the following in writing:

1. I will stay home if I am unwell, or if someone in my household is unwell, or is displaying the following symptoms:

* Fever and Chills	* Stuffy or runny nose
* Cough	* Loss of sense of smell
* Shortness of Breath	* Headache
* Sore throat and painful swallowing	* Fatigue, etc.

2. I agree to complete a routine daily screening process prior to the start of an association activity each day.
3. I agree to stay home if I have been in contact with a person that has a confirmed or suspected case of COVID-19.
4. I agree to stay home if I have travelled outside of Canada in the last 14 days. Additionally, I confirm that I will stay home if I have been exposed to someone who has travelled outside of Canada in the last 14 days.
5. I acknowledge there are inherent risks associated with participating in activities. By attending association activities, I understand and assume all risks associated with potential exposure of COVID-19.
