- 6. 2021 VSA focus for the season:
 - a. Safe return to soccer (Return to Train)
 - i. Covid 19 precautions
 - Field entry & exit Covid check before heading to pitch, arrive at pitch, Covid check again, no parking up front, no spectators on pitch. If sick don't show up



- Covid-19 daily parent, coach, and player checklists -Players -Masks to be worn to pitch then can take off for practice and then put back on to leave. Coaches to wear masks on pitch
- 3. Equipment children to have equipment on and bring own balls if possible
- 4. Food/beverage Concession will have no cooked food. Water and prepackaged food(chips,pop,gatorade,candy)only
- 5. Shack and ball shed access Shack limited to a few at a time going in or out, no gatherings inside. Ball shack NO ENTRY at this time, balls will be brought out
- 6. Cleaning High traffic areas cleaned and high touch areas cleaned. Balls will be cleaned. Hands sanitized before and after
- b. Fees and Bond Cheques/Volunteer Hours/Board & Executive Positions Fees stay same due to cost of Covid supplies. Bond cheques this year 1 \$100 cheque. Volunteer Hours this year - Mini down 2 hrs /player, Youth down 2 hrs/player
- c. Referees/Officials Have 1 official for the district this season. In desperate need of reffs(Must be 16 years and older)
- d. Coaching Staff Need NCCP# to coach, need to take making ethical decisions course. If you sign up now you can still get course for free. Need to follow all Covid protocols. Will be 8 players to 2 coaches. 1 of the coaches must be trained. If you are not trained, the age group you requested to coach being male or female that age group will not be able to open up. You must be trained.
