8. Director's New Business

8.1 OMAHA Pilot Project – Tim Giandomenico, OMAHA Chair

Fear the North summary – pooling of teams in certain areas to develop players

90 applicants to form 3 teams with 20 players on each roster – the players that didn't make it went into house. 9 players from Revelstoke made the tier 2 Salmon Arm. The philosophy is that players should play at their level. OMAHA decided not to have open borders and drafted a six-zone plan.

What did the vote needed to pass? Majority vote 50% plus 1. Two associations were against the vote – Winfield and South Okanagan. OMAHA has a lot of work to do to roll this out both internally and externally.

OMAHA Meeting ??? AGM ??? How will ice allocation be managed? How is OMAHA going to support the ice allocation? Agreements will be in place where associations will support teams. Associations can swap hosts if the majority of players are from the same town. Ie. Winfield is set to host Tier 3 and Vernon is Tier 2 – if most of the Tier 3 players are Vernon and Tier 2 is Winfield then the host cities can swap.

How are registration fees determined? Registration fees in Salmon Arm were based on the registration fees of the host association. Looking at having a unified fee where everyone pays the same as ice costs vary depending on the community. The positive outlook is that this model is not based on money but the players skill.

Timeline and communications from us – how do we handle the communication about the changes? FAQS in the newsletter – question and answer Open house night with OMAHA reps.

ACTION: Set an open house date in late March

How are we going to manage our registration so that we don't exceed the cap? Gord explained that with other associations hosting a rep team it should alleviate ice in Vernon. We need to ensure that our local players are still able to play in their home arenas.

Jesse's concern is the day we host 19 kids from other associations and are sending 14 kids and our registration is capped we will need to strategize.

The assumption is that if our kids are developing, then the players will be moving to other associations and freeing up ice here.

Brendon explained how this model is positive - allows bubble players to play where they belong and hopefully help with attitudes of players that don't make their desired team. This also provides more parity in the recreation levels as players are playing like players.

How will the AP Program work? The Coach will list their AP players – it will vary by location, depending on the player's availability as well as attitude. The AP policy will need to be formulated by OMAHA.

Each zone will form a committee, and they will choose a coach and the evaluators for that team.

Will this expedite our try outs date? Triple AAA, double AA, then it follows – don't require a tiering weekend anymore. August onwards - this is a concern from the perspective that this should not push back the start date for recreation players.

OMAHA is piloting this for BC Hockey and has applied but has not received approval. This is a fluid situation and can be tweaked this year. This is not committed to for more than one year. If this is not successful, will it be terminated?

Players can make a tier 2 team but not want to travel, can play down if their local association is hosting.

What are the Service Agreements for the players? What level of service is provided with each team—OMAHA does not have an answer yet, they are working through this.

Travel – Can the teams share the practices at different associations. Ie. Vernon and Winfield swap ice times?

Are we going to fly under the same flag for a team name? Currently it's under the host but this can be looked at.

Will you release parameters on what is success? What is success? BC Hockey wants surveys from associations, players, parents, coaches

> Local concussion management programs – some are \$120; Impact has offered it at \$35 a player for baseline testing. Hit check program is game based, similar to reactionary games which targets our athletes. Kamloops uses this for their teams. What do we want our reach to be? We would incorporate the baseline test into the registration fees. The treatment is at the cost of the player. Impact will offer the treatment, but the player isn't required to go there – they have the freedom to choose their treatment provider. We can also look to offset the costs for the first year with funds raised from the golf tournament

Some of the programs can be covered by extended benefits.
