Atom: Currently undefeated in regular season (Tier 4). Attending a tournament Dec 27-29 in Cochrane.

**Peewee:** Were approved to move to Tier 5, had to pay \$1200 in total to NAI to move. Start games in Tier 5 next weekend. Planning to host a tournament in Holden February 1-2 due to lack of ice in Viking.
