U9 – practicing twice a week. 15 players. October 30th scrimmage. November 6th and 7th play Mannville. Short on coaches.

U13 – Tier 5. 11 players. Waren started coaching. Jordan, Terri, Joshua and Connor have helped coach.

Equipment – Laurel ordered jerseys; should be here before picture day. Joleen sent out what we have in stock for socks. Holden goalie equipment isn't in Carena.

Referee Clinics – online only option for Viking refs this year. 3 hours online. 8 hour course for new refs. VMH will pay for ref course for all new 1st year refs.

Sponsorship - U7 – Dee Jay Plumbing U9 – Skully's Oilfield U13 – Ritchie Agencies \$1000/team. Viking Pharmacy and JD Construction sponsoring U9 jerseys. Thirsky's Oilfield sponsoring jackets for new kids and jerseys for U7.

Casino & Fundraising – Scheduled for Q1 of 2022. 50/50 tickets handed out to parents. Need to inquire with AGLC if able to run 50/50 draws at home games. Could pre-sell a 50/50 board. Rosanne will deposit 50/50 money. Last year's Atom team inquired about their 50/50 money earned last year;

determined that money stays within VMH. Fundraiser Policy added to website. Beef jerky fundraiser due October 28th.

Website – Bylaws need to be updated for website. Picture Day date added.

Player Development – Sean Malone. Not many attended last sessions from U9 and U13; need more committeent. \$125/session. Have paid \$1050.00 to date. Ashley Grantham scheduled this coming weekend. \$2500 grant not yet confirmed. Going forward PD sessions will be during practices not on weekends. Will look into one Monday/month with Sean. Possibly need to charge a fee next year for power skating; could open it up to nearby associations. Agreed not to spend more than \$2500 on PD until grant notification is received.

Picture Day – November 4^{th} – times TBD. VMH will pay \$16/player for photo. Require approval for entrance and set up in Carena. No skates for pictures. Joleen needs a cheque to pay photographer.

Discipline – no issues.

Team Ramp - \$25/team. Will set up for all teams. Included COVID questionnaire. Attendance and questionnaire required to be submitted for every practice and game.

Criminal Record Checks – Due by November 15th or cannot go on ice with team.

COVID Requirements -100 spectators total in Carena. Split 50/50 with visiting team. Time box workers aren't included in 100 spectator limit. Must wear masks in time box.
