- 3. I assume all the risks and damages associated my travel to and from my Professional Club, NCAA Team or Team location or Leagues or Competitions location.
- 4. I acknowledge, understand and accept that WPC travel liability insurances will not apply to my participation on my Professional Club, NCAA Team or Team's activities and in related Leagues or Competitions and will not cover me for my travel to or from my Professional Club, NCAA Team or Team, Leagues or Competitions location.
- 5. I agree to assume all costs related to obtaining travel and liability insurances and confirm that my Professional Club, NCAA Team or Team will be covering me for any travel or liability damages and I commit, upon WPC's request, to provide proof of such insurance coverage to WPC.
- 6. Should WPC Chief Medical Officer (CMO) requires that I return to Canada due to COVID-19 aggravating circumstances or for health reasons, I will comply with WPC CMO's request and will assume all travel costs related to my return to Canada.

Release of Liability
