



I, _____, player with the _____ team within the WDAFA organization, promise to abide by the following:

1. I will read and abide by the CDMFA and WDAFA Codes of Conduct;
2. I will never put my hands on anyone, (player, other parents, staff or officials) out of anger or without permission. This includes but is not limited to pushing, hitting, kicking, punching, touching butts etc.;
3. I will never verbally abuse anyone, (player, other parents, staff or official). This includes but is not limited to swearing, verbally berating, purposely embarrassing or name calling;
4. If a conflict arises, I understand that it is mandatory to ensure that 2 neutral adults as well as my parent or guardian are present during any disciplinary conversations with WDAFA staff. THIS IS NOT NEGOTIABLE and I will ask to find another adult if I am uncomfortable. The neutral parties must NOT be a spouse or family member of the WDAFA Staff member;
5. I understand that the Trainer's decision to have me play or not after being injured is final. I understand that the Head Coach chooses when and if players play during games, and if there is an issue I will have my parent or guardian submit my concerns in writing to the Team Manager;
6. I understand that I am responsible for my behavior on and off the field. I understand that I am expected to listen to and respect the Coaching and Training Staff at all levels. I understand that my attitude on and off the field may affect my playing time during games;
7. I will ensure that I attend as many practices as possible and if I am going to be absent I will ask my parent or guardian to inform the Team Manager. I understand that being absent from practices can affect my playing time during the games;
8. I will ensure that I treat all players, staff, officials and opposing teams with respect regardless of what is happening. I will do my best to ensure that all players on my team feel welcomed and included and will speak up if I see any other players being bullied or made fun of;
9. I will ensure that I am dressed and ready to participate for practices at minimum 5 minutes before the scheduled practice times.
10. I will ensure that I have all required gear with me for all practices and games. If any of my gear becomes broken or is not fitting appropriately I will ensure I go to trained WDAFA Staff members to fix these issues.
11. I will follow directions given by not only my Head Coach, but Assistant Coaches and Jr Coaches as well. I understand and respect that their position is to coach and guide me to be a better player, regardless of their ages, and if I refuse to listen to any of the other coaching staff or are blatantly defiant of their requests in the event the Head Coach is not present that this can affect my playing time during games.
12. I understand that I am here to play football to learn the game, enhance my skills, and most importantly HAVE FUN.

I understand that by breaching any of the above points that I may be benched from practices and games. If my actions do not improve, I understand that I may be removed from the team for the duration of the season, and if the actions continue then I may not be allowed to return to play with the WDAFA organization indefinitely.
