Presidents report

-Wetaskiwin Field and Scoreboard Update: Received an email from the City of Wetaskiwin stating that WADAFA cannot use the field until May. Codey has responded to the City that there must be other suggestions on the use of the field as the lights are needed for Girls practices. A request for a board member to express our concerns directly and face to face with someone from the City. The other issue is the repair of the Scoreboard.

Registration update

CDMFA Report:

A few volunteers are requested to try to gather hotdogs/buns at a reduced cost for Spring Camp.

-Suggestions for Spring Camp events are requested, such as having Edmonton Elks players come out for the kids/community. Codey will check into the availability of a Professional Player. -Tony is no longer training.
