Board Business:

1. President's Report

It has been an exciting year.

We started out with a very Successful Female program in the Spring. Our athletes did amazingly well, with a few of them moving on to play for Football Alberta. Keep up the amazing work.

We followed up the Female season with a try it out night before the fall season started. This had an amazing turn out, and we had quite a few players register from this event. I would recommend doing this again.

For the Fall season, we started out with Flag, Atom, PeeWee and Bantam teams. While we struggled with numbers for a bit, we managed to recruit enough players for all the teams. Through a few setbacks, we had to send our Bantam players to other communities to be able to finish their season. While that may not have been so great for our Warriors, the ones who wanted to continue the season, all found a place to play, and that is the goal, to keep kids on the field. These players will be back with the Warriors next year, to rebuild the Bantam program.

Football day was a great success as always. We had the Edmonton Elks come out, skills competitions and a game. The Silent Auction, which is one of our fundraisers, was a great success as well.

New this year was the Player of the Week. This was a great program that was loved by the kids. We had 3 main sponsors for this, Manluk, Boston Pizza and Dyck Insurance. Kids got to take the sign home for the week and received a free pizza. I would recommend this for the following years as well.

We also had our "own" day at the Edmonton Elks game. We had many Warrior players and families join us there, and even got to sing the fight song. It was a great team building event.

Over the next 2 years, we have a lot of helmets expiring and will need to be replaced. Working with Jason, we have managed to start the replacement process for helmets, along with some other much needed equipment. During this process, we are unable to now acquire Gold helmets. As a Board, it was decided to switch to white. All helmets ordered are white in color. Jason has secured a company that will paint all of our existing helmets as a donation, and another company that will donate the paint as a donation. This has saved thousands of dollars. We can't thank Jason enough.



We had several successful Fundraisers this year. 50/50, with the Spring season and the fall season, Bottle drives with both seasons, and Card sales. Every little bit helps. Most of this goes back into the club in the form of equipment and needed supplies.

As a Board over the last 2 years, we have tried to change the culture of football, to have it more player focused, and with that comes challenges. We have had several challenges over the last couple of years, and that includes people signing up, resigning and trying again to fill those positions. While we have had a few constant people, there have been several changes in the board, and often left with just a few of us. My hope is that we have dealt with most of the "hard" stuff, and it should even out and be more player and game focused. Football in Wetaskiwin can't run without volunteers to make it happen. While not always easy, it is rewarding at the end of the day.

Some recommendations for the incoming Board:

The spring season is coming hard and fast. You need to keep the Board meeting next week, to gather as a new group, to discuss and set up how that is going to look.

I would recommend looking into having a Spring Flag season, as well as the female tackle season, if coaching staff allows. The Spring Flag season is shorter and will also bring in revenue. This is a big upcoming thing within the CDMFA and Football Alberta.

I would recommend opening the fall season early again. Get as many registrations as you can before teams have to be declared at the end of June. This makes a big difference at the start of the season.

If the new board keeps the volunteer formats, I would recommend increasing the number of obligations the fall parents have to commit to, to at least 3. With more players and more games, we fell short in a few areas in the fall, where we had the same families volunteering all the time.

I would recommend making and keeping relationships open with the CDMFA. I know in the past, it seems like they are not on our side, but that was not my experience this year. Ryan and Ali were more than helpful, courteous and knowledgeable. I could not have made some things happen this year without them. While they expect us to run our own Club, under our policies and Bylaws, they are always there for support and guidance, which to me, was invaluable.

I wish the Warriors nothing but success.

- 4. Bylaw changes as recommended by AGLC for our Casino license
 - Article 3 Membership
 - 3.1 A member of WDAFA is defined as:

3.1.3 Any player a minimum of eighteen (18) years of age, who has signed the required "Player Statement" for the season they are registered for;"

3.2 states that all members in good standing are eligible to vote at the yearly AGM

This would mean that any player up to age 18 is considered a voting member. I am thinking this should be any player a <u>minimum</u> of 18 years of age? If so, this would be unnecessary as the Association does not offer any programs for players over age 18. If it is for players up to and including 18 years of age, it would then need to be clarified that these members do not have voting privileges nor can they be nominated/elected to the board of directors.

• 3.1.4. An Honorary Member:

3.1.4.2 Honorary members are eligible to be elected to a board position. - REMOVE

The opportunity to be elected to a board position is not included with any of the other membership categories so the recommendation would be to remove 3.1.4.2. You could then add to 3.2 that in addition to being eligible to vote at the yearly AGM, members in good standing are eligible to be elected to the board.

o 7.6. Payments

7.6.1. No Elected Executive Officer, Board Member or member of WDAFA will receive any remuneration for their services. unless unanimously agreed by secret ballot vote at a duly constituted Board Meeting, after second reading give of such motion providing for the same. - REMOVE

7.6.2. Reasonable expenses incurred while carrying out duties of the Society may be reimbursed upon Board approval.



Bylaw 7.6 describes that no elected executive officer, board member or member of WDAFA will receive any remuneration for their services unless unanimously agreed by secret ballot vote at a duly constituted board meeting. Please be aware that AGLC policy does not allow for executive or board members to be paid (salary, wage, honorarium, dividends, volunteer appreciation, etc.). Members who are not executive or board members may be paid for services to the group. We <u>do not</u> require this bylaw to be changed, just be aware of the policy and ensure your group complies.
