- 4. I have sent the proposal I shared with you last meeting that Winfield & Warburg used to the President of Millet MHA and also to the VP. I have not received a response or any feedback from them. I have confirmed that their President and Registrar have resigned from their positions. The next step I am going to take is to share the document with the rest of their Board members and hope that someone will show some interest. If not, I think we need to put this to bed until Millet approaches us.
- 5. I have spoken briefly with the concession operators. I have a meeting set up with them for March 28 to outline what our expectations are for next season and make sure they understand what we want as far as operating hours for it.
