Registration – Susan H / Amy B (7:11 PM)

- Volunteer Fee
 - Registration RAMP Volunteer module doesn't allow for defered payment
 - RAMP does allow deferred payment (Partial, minimum 0.01 as part of registration, then balance at end of season)
 - PJ Could we build volunteer packages that are not date / hour specific
 - Susan: Yes, but we can't track whether or not they actually do it
 - Registration fee Can't be by family, only by player
 - Mike V: Suggests we just add the \$100 to the registration fee, defer the \$100 until later
 - We can do this, but again this will be by player, not by family
 - Ryan: Can we ask Ramp to have a defered payment with no upfront fee?
 - Action Item: Susan will ask RAMP, and if they can charge just once for the family
 - Susan: What about Blastball, TBall?
 - PJ: Don't charge Blastball or TBall
 - Kevin Hall: Suggests U9 and up. Everyone agrees.
 - Susan: How many hours before bond is \$0? PJ; 5 hours.

 - PJ; Creates a parallel with Huskies / Firebirds
 - Susan; The issue is New Hamburg vs Wilmot

- Ryan says this could be discussed
- John V, Jamie etc... think this is a great idea promote high level ball to younger players.
- John V Suggests hosting these games would create excitement in the community
- PJ; suggests we should be cautious changing U20 name to Mustangs as this will be a one and done season
- Mike V: Has concerns with running a different team with different rules financially
- Kevin H: Agrees we should support them, but wonders what the benefit is to have them under WSA
 - Ryan Simplifies insurance, diamonds, etc...
 - Ryan Suggests this is a good way to retain U20 players to continue playing once this team goes to U23 next year
- Ryan; Says for tonight we need to decide if we are in general support, and then we can address the details as the discussion moves forward

 - No Player may be registered on another teams certificate, unless properly released from the players former team. A player requires a release from the affiliated home center and the next closest affiliated center to the home center. In the case that the home center is not an affiliated center, it will be the two closest affiliated centres to the players residence in order to be able to register with any other center in the province. If the new center is the next closest, then only one release shall be required. If there is only one center closer than the distance between the players residence and the players proposed new center, then the player only needs 1 release.
 - Proposed wording:

- No Player may be registered on another teams certificate, unless properly released from the players former team. A player requires a release from the affiliated home center and the next closest affiliated center to the home center. In the case that the home center is not an affiliated center, it will be the two closest affiliated centers to the players residence in order to be able to register with any other center <u>not more than 3</u>
 <u>affiliated centres away.</u> If the new center is the next closest, then only one release shall be required. If there is only one center closer than the distance between the players residence and the players proposed new center, then the player only needs 1 release.
