Finance (7:43 PM) - Mike VdW

- \$2000 in outstanding uncashed cheques
- \$65,000 cash
 - o Less previously Approved \$4500 for new audio equipment
 - Police Check reimbursements still outstanding
 - Action Item: Mike V to complete police check credits, and give them to Susan to distribute

Budget for Equipment Purchases (7:46 PM)

- Hitting Mats (3+ \$350 USD)
 - o PJ Suggests larger mats as we have the space in the arena
 - o Purchase 4 as they are on sale
 - Kevin H: What is the value add of these mats, and is there any training to work with these mats?
 - PJ: There is a detailed manual included
 - PJ: Safety on the concrete floor is the biggest benefit to having these
 - Consensus: Yes, put these on the budget, details to be determined 3 minimum, 8
 would be ideal, might make sense to buy a larger piece of turf
 - Mike V: Need to consider what our Spring Clinic goal is: LL might not make sense, but rep teams this would make more sense
 - PJ: Main point here is to discuss a budget value. What do we want to list on the budget for this?
 - \$2500 budget item 3 PRO mats, plus whatever left to make our own mats
- Blastball Gear (3+)
 - Honking bases, balls, hula hoops etc...
 - \$500 budget item
- Team Bags (T-Ball & Coach Pitch) HB60030 \$50 ea. (20 Bags Numbered)
 - Some bags are unusable
 - o Kevin H: Have we taken inventory of bags yet?
 - PJ: Not yet
 - o PJ: Looking at buying a slightly larger bag than the current bags for TBall / Coach Pitch
 - \$ 1000 Budget Item for now

- Pitching Machines (~\$8000)
 - Kevin H: Reminder that Friday night league has donated money that they hoped to go towards a pitching machine
 - o \$15,000 budget Item
 - o Kevin H: Suggests an equipment subcommittee to discuss needs
- Scoreboard
 - \$15,000 Budget Item
- Indoor Training Balls 12" 3 Dozen
 - o \$300 Budget Item
- Tees TBD
- Balls etc.. should be year over year and be in the budget already
- Bats \$2000
- Kevin H: How do we manage outgoing equipment?
 - o Ryan R: Suggests we should meet with rep coaches individually to discuss
 - Kevin H: Flavor of this should be we have a new equipment chair that is trying to inventory our equipment
- Action Item: Equipment Inventory Jamie, PJ, Kevin H, Kevin R
