

# **PRESIDENT REPORT**

Helping to guide and lead a community-based, non-profit organization like the Winnipeg Youth Soccer Association (WYSA) is a challenging and rewarding role. Without the unending work done by our coaches, managers, parents, volunteers, Board Members and staff, it would not be possible.



Keeping focus on our young athletes and the game we all love needs to continue to be our main driver. This will remain the focus for 2018-2019. The soccer landscape is changing and WYSA needs to look for guidance from within our membership and our governing bodies as to how we can maximize the opportunities that are coming our way. The successful launch of the Canadian Premier

League with our very own Valour FC and the announcement of Canada as a joint host for the 2026 World Cup are both the types of engagement vehicles that we need to help move this sport forward.

Internally, we need to be flexible and open minded as to how we address the changing landscape of soccer and look outside the box and to our history as to how we can improve or take lessons from. WYSA is an association of soccer clubs. In this association, we need to realize how important it is to have strong competition in our league association. The strength of the association is defined by working together to better the experience for the playing and paying membership. I identify a need that to be successful as an association we require an adherence to standards that are good for our customers and clubs and make soccer the sport of choice. The 'greater good theory' should prevail, whereby club priorities at times do tend to lead the thinking and the agenda. I can't but help, believe that if this one thought drives our focus, then we will increase the probability that we will get better results for the game we all love.

Governance reform once again is a necessary mention for me. Governing bodies, Manitoba Soccer (MSA) & Canada Soccer (CSA), have positioned a vision that incorporates a free flow of players

and a standards-based adjudication as to who may provide programming in this Province. WYSA as an association, is currently not built for this. Much discussion in the short term with some heavy lifting in the medium term, should hopefully allow WYSA to position ourselves successfully as we gather momentum. Governance reform should identify the need to take a more holistic approach to youth development and look to build upon the foundation that we have in place. Focusing on the state of play at youth level, including coaching, the affordability of the game, and the pathway in place from grassroots to higher levels of the sport needs to be a part of a Governance review. This process should complement the work being completed by the MSA & the CSA, which will hopefully help WYSA to benchmark ourselves against our peers and better understand where key improvements need to be made for the game to continue to develop.

Highlights from the past year:

- The Players Tournament and the resultant subsidy it provides, continues to motivate us with how engaged our membership is. It provides access to the game, for those, who may need the support.
- This year we listened to our membership and adjusted our U9 U12 recreational fees down. It
  was felt that WYSA contributed minimally to the programming and development of the
  member recreational leagues and as a result we adjusted, with the hope that the membership
  will derive value and hold the member Districts accountable for the dollars they spend.



Sponsorship opportunities were
once again a focus for the WYSA staff.
 Several renewals and a Division
 Sponsorship arrangement, being a
highlight for me. I thank all our sponsors
for their support and commit to continuing
the focus towards more.

Programming changes were made to

our Inner Soccer initiative, the Mobile Mini Soccer program. This allowed the District's to better







align and schedule their teams who lead the weekly sessions to provide a more consistent and branded strategy. It is a highlight for me when I attend these sessions in seeing how our youth players represent their clubs so well and engage so positively with the mini player. I thank the clubs and the WYSA staff for passionately supporting this program

WYSA continues to administer the outdoor and indoor soccer leagues for both recreational and competitive leagues. The outdoor programming focused on standards whereby field allocation and referee support was aligned to the level of competition being served and the financial outlay of our customers. WYSA continued with three tournaments, including the largest indoor and outdoor tournaments in this part of the country. The WYSA 3v3 tournament with the support of Valour FC was played out at the Investors Group Field and was a highlight for me over the summer. Our high school indoor soccer league continues to grow, and, we will continue to look at many ways to better the experience of our members. It would be remiss of me, not to recognize the hard work and commitment of the WYSA staff in all that they do to accomplish the above.

In highlighting what we are doing well, I also need to address what does continue to be a concern for me. We continue to be challenged to attract and even more disconcerting, retain the players once they have decided to participate. This is problematic for me as players and parents point to quality coaching at a young age as they work on the basics of agility, balance, and coordination while learning the game as a priority. Encouraging creativity and having fun while engaging in competition is something we can continue to strive to do. Promoting a development program and coaches is a paramount task in 2018-2019 for me.

A recurring message received from parents was the lack of available information to guide and support them in making crucial decisions about their children's participation in youth development in soccer. I recommend that WYSA undertakes significant measures to better educate the public in this area, ideally, being done with the collaboration of the governing bodies, and third parties such that identical information is rolled out provincially and nationally across all the member leagues.

# **WYSA Audited Statements**

Within the Annual Reports package, you will find a copy of the independent audited financial statement from Booke and Partners. We are happy to report that the financial statements fairly represent the financial position of WYSA and are in accordance with the Canadian standard for accounting principles of not-for profit organizations. Overall, the Association is in good financial position with a moderate surplus of retained earnings.







# 2017 Outdoor League Season

Building on our efforts for a more consistent and thoughtful schedule, we continued to fine tune our scheduling processes of implementing and sticking to a single day of play for all developmental league and premier league teams, meaning they played on the same day of the week (1 match per week). Across all of our leagues, recreational, developmental and premier, we scheduled a total of 2,715 matches. We had a total of 541 teams registered for the outdoor season; 379 in the U9 – U18 Recreation Leagues; 95 in the U9 – U12 Developmental Leagues; and 67 in the U13 – U17 Premier 1 & 2 Leagues.

The 2017 outdoor season marked the third year in which all U9 – U12 participated in the Long-Term Player Development (LTPD) framework. In 2013, WYSA purchased 75 pairs of smaller sized goals



which were distributed amongst the 5 Districts for recreational and competitive teams to help facilitate this program which emphasizes smaller sided games, smaller roster sizes, thus more touches on the ball per player, and a deemphasis on winning/losing with the removal of published standings. While

there may be some obvious resistance to the removal of standings as a measure of immediate shortterm success, the aim is to provide players and coaches better opportunities to develop their skills.

The other critical component to the success of the program is coach education and certification. We've been working with the MSA and our Clubs to provide opportunities to train as many coaches as possible, as well, provide coaching resources through our website and social media in a variety of areas. With smaller sided games, more touches for each player, and less of an emphasis on winning

and losing, we are confident over the long term, players and coaches will be better developed and enjoy the sport more, which will ultimately strengthen our game. While the CSA and MSA have provided a framework to implement the LTPD model, admittedly, we are still learning what works and what doesn't as each soccer association's programs are unique, but those challenges will not deter us from endeavoring to provide the tools necessary for the long-term success of our game. Moving forward we will continue to make the necessary adjustments to increase the success of the program.

For the fourth year in a row, WYSA organized season finale jamborees for all U9 – U12 recreational and developmental teams. The jamborees included 2-3 matches for every team, a free team photo at our photo booth station, food, and activities for each team such as the shot speed and shot accuracy stations. The feedback we've received through our surveys and coaches, parents, and players has been nothing short of over-whelming and we'll be looking at ways to improve next year's



event. I would also like to personally thank the Board and Staff of Winnipeg South End United for their tremendous support and efforts in making the 2017 jamborees successful. We could not have done it without you!

We must also recognize our Under

17 Bonivital SC boys who won the MSA Provincial Championship and went on to win the U17 National Club Championship as well! A tremendous accomplishment which was celebrated quite often over the last year!

# 2017 Boston Pizza Players Tournament

In 2015, the WYSA Board of Directors voted to create a player subsidy fund to help address the shrinking subsidy funds available to youth soccer players and their families. This meant switching the recipient of our annual summer tournament proceeds from the Children's Hospital Foundation of Manitoba to a newly created player's subsidy fund. Over the 23 years, WYSA contributed more than







\$300,000 to the Children's Hospital Foundation, which is due to the tremendous support of our soccer community.

In partnership with Boston Pizza, we were able to raise another \$10,000 from the tournament and a total of \$33,000 over the last 3 years. Those funds are used to help support local soccer players



and we are confident that the player subsidy fund will leave its own amazing legacy as interest and participation in the tournament seems to get stronger each year.

The 2017 tournament was a tremendous success with 174 teams participating which was our maximum capacity. Registration reached full within 72 hours which is a credit to our

organizing committee and our community for their support!

# 2017 WYSA 3v3 Tournament

The 3v3 Tournament was introduced in 2015 and building on that we once again increased registration from 60 to 84 teams! We again used Assiniboine Park as the playing venue with 10 different pitches going at one time. Matches were a total 30 minutes in length (two 14 min halves with a 2 min halftime) and teams were guaranteed 3 round robin matches with rosters capped at 6 players and two team officials. The big bonus was players could form teams without boundaries as long as all players were registered in the 2017 WYSA outdoor season.

# 2017 Mobile Mini Soccer Program

In 2015 WYSA took over the administration and operation of the Mobile Mini Soccer Program from the St. Charles Soccer Association. We continued to build on the program which offers a one hour drop in session which teaches children the fundamental skills of soccer at 4 different inner-city schools through May and June. Our Coach Coordinator, Andrew Patton, lead the program this year organizing the training sessions and coordinating with our District Clubs who volunteered teams to help with

running each session. The WYSA Event Coordinator was responsible in overseeing the Coach Coordinator and ensuring he had the tools they needed for the program to run smoothly.

Mobile Mini was held Monday – Thursday, for 5 weeks, beginning on Monday, May 15<sup>th</sup>, and



ending on Thursday, June 15<sup>th</sup>. Each day of the week was a different inner-city school location. Monday was held at Weston School, Tuesday at Brooklands School, Wednesday at Lord Selkirk School, and Thursday at Pinkham School. Over the course of the 5 weeks, we had 881 kids participate in the program, with the Brooklands School being the most popular venue, 347 (39%), followed by Weston School at 219 (25%), Lord Selkirk School at 202 (23%), and Pinkham School at 113 (13%). Overall, our participation increased from 527 to 881 kids which

is a 60% increase!

# 2017 – 2018 Indoor League Season

The 2017-2018 indoor season had a total of 250 teams registered; 134 in the U9 – U18 Recreation Leagues, 70 in the U9 – U12 Developmental Leagues, and 46 in the U13 – U17 Premier 1 & 2 Leagues. As we moved to half field play, our number of teams have slightly decreased due to teams playing 9v9 and carrying a higher roster number.

# 2017 – 2018 Indoor High School Soccer League

This season the Indoor High School League had a total of 37 teams registered, 17 male and 20 female, playing from October to March. Over the past 4 seasons this program has grown in popularity and with the new WSF Soccer North facility being built, the league grew once again from 32 teams in 2016 to 37 in 2017. We are endeavoring to continue to grow the league again in 2018!

# 2018 Golden Boy Indoor Tournament

The 2018 Golden Boy Tournament was our 10<sup>th</sup> anniversary of the indoor tournament and fittingly we hit a record number of registrations, 176 total – 110 ¼ field and 66 ½ field. The tournament was held February 15 –19 at the U of W RecPlex, WSF Soccer South, and WSF North Facility indoor

complexes with 28 divisions, including 42 out of town teams. The out of town teams represented Thunder Bay, Ontario, Regina and Yorkton, Saskatchewan, Minot, North Dakota, and Minnedosa and Brandon, Manitoba. We received many compliments regarding the event, such as the on-site athletic therapists, LOC communication, individual team packages, 50/50 and raffle opportunities, the overall website design, and how timely the results were posted.

Throughout the tournament we also had special edition 10<sup>th</sup> anniversary merchandise available at all of the playing venues and by the final day we had sold out of everything! Canteens were available



at all tournament locations for the duration of the event. We had custom medals made for this tournament that were a huge hit with the participants and will continue to use those medals in the years to come.

An evaluation survey was sent out to all team officials that participated in the tournament once the event was over asking for feedback on the event and what we can do to improve in the upcoming years. Of

particular note, the feedback from the tournament survey was that nearly 96% of respondents would participate in this tournament again and would recommend it to other teams.

In closing, I would like to sincerely thank the WYSA Staff, Cheryl Ginter, Scott Dixon, and Christine Comeau for their efforts and dedication over the past year. I would also like to thank our Board of Directors for their continued efforts to help build and grow the beautiful game here in Winnipeg. WYSA is committed to providing quality soccer programs and services that are accessible and affordable as the power of sport reaches far beyond the soccer pitch.

# **FINANCE REPORT**

Once again, Booke & Partner has completed the 2017-2018 fiscal year audit for the Association – these statements have been included in this annual report package. The Board of Directors prepares the annual budget in January for the upcoming fiscal year and uses its best judgement to anticipate revenues and expenses. Sometimes we are spot on, and, sometimes we are off the mark, but, that is what happens with most organizational budgets as large as this, especially when you're trying to anticipate costs over a year in advance. As such, part of good budget planning and taking into consideration the debt being carried, the association plans for a surplus of not more than 5% each fiscal year. At the end of the 2017-2018 fiscal year, the association was in a positive standing, \$48, 105, which equals a 3% surplus and is within the parameters set by the board of directors. Much of the surplus was due to the direct efforts of the staff increasing tournament revenues, sponsorships and grant revenues. Below is a percentage breakdown of our notable revenues and expenses:

# Revenues:

the feedback in our event surveys to help us plan for the next year to improve the event.





# DIRECTOR OF REFEREES REPORT

In the last few seasons, thanks to Mark Potter's (referee assignor) insight, and MSA instructors, WYSA hosted another youth clinic. One at Grant Park and one at Phoenix, where close to 50 of our young referees came out and practiced their signals, positioning and discussed different game scenarios. With Hector Vergara in the lead, the drills and question period were both fun and a great learning experience.

The recreational finals this year I found extremely challenging due to the weather, but our referees worked very hard and did a great job. This year, as in every year, had it challenges, and our



soccer community met them with resilience and resolve, and with that we improve our referee program. Again, I would like to thank the District Referee-in-Chiefs for all the hours they put in with our mentoring program.

During the Golden Boy Tournament, in collaboration with the Manitoba Soccer Referees Association and the MSA, I set up a recruitment booth

with the purpose of informing the soccer community on how to become a referee. It ran for two days from 9am – 6pm, on the Saturday at the WSF North facility and Sunday at the WSF South facility. # Independent Auditors' Report

To the Members of Winnipeg Youth Soccer Association Inc.

### Management's Responsibility for the Financial Statements

In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

# Winnipeg Youth Soccer Association Inc. Notes to the Financial Statements March 31, 2018

### 1. Nature of the organization

Winnipeg Youth Soccer Association Inc. (the Association) exists to promote and develop youth soccer in Winnipeg. The Association is a not-for-profit corporation pursuant to The Corporations Act (Manitoba) and is tax exempt under the Income Tax Act.

# 2. Summary of significant accounting policies

The Association follows Canadian accounting standards for not-for-profit organizations in preparing its financial statements. The significant accounting policies used are as follows:

### a) Fund accounting

The Operating Fund accounts for assets, liabilities, revenues and expenditures related to the Association's equipment, youth registration, referee fees and administrative activities.

Assets, liabilities, revenues and expenditures designated for a special purpose are accounted for in the Restricted Fund. As there were no transactions during the fiscal year or balances at year end that were for a special purpose, a Restricted Fund statement of financial position and statements of financial activities and net assets were not required for 2018.

### b) Revenue recognition

Revenues are recorded on the accrual basis. Grants received generally pertain to programs which run in the same year and, as such, are recorded as revenues when received and collectability is reasonably assured.

Tournament fees are recorded as revenue when collectability is reasonably assured and the event has occurred.

### c) Amortization

Amortization is provided at rates designed to write off equipment over their estimated useful lives as follows:

Goal posts	10 years straight line
Computer equipment	5 years straight line
Furniture and fixtures	5 years straight line

### d) Accounting estimates

The preparation of financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reported period. These estimates are reviewed periodically and are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

# 2. Summary of significant accounting policies - continued

### e) Financial instruments

The Association recognizes its financial instruments when the Association becomes party to the contractual provisions of the financial instrument. Financial instruments are initially recorded at fair value with subsequent reporting at amortized cost.

It is management's opinion that the Association is not exposed to significant credit, currency, interest, liquidity, market or other price risk.

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Association is exposed to less than significant credit risk as receivable amounts are not material.

Currency risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in foreign currency rates. The Association is not exposed to currency risk as all transactions occur in Canadian currency.

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market interest rates. The Association is not exposed to interest rate risk as the interest rates are fixed on all external debt.

Liquidity risk is the risk that the Association will encounter difficulty in meeting obligations associated with financial liabilities. The Association has maintained positive working capital that minimizes its exposure to liquidity risk.

Market risk and other price risk are the risks that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market prices. The Association is not exposed to market risk as it has no material assets exposed to market fluctuations.

Management believes these risks are manageable and do not represent a threat to the Association's ability to continue as a going concern.
