

FINANCE REPORT

The Executive Director provides monthly financial reports to the Board of Directors to ensure they have detailed, timely, and accurate financial information. The Board of Directors prepares the annual budget in January for the upcoming fiscal year and uses its best judgment to anticipate revenues and expenses. The overall operating budget for the 2018-19 fiscal year was approximately \$1.7 million. In 2013 the Association received a \$100,000 loan from the Winnipeg Soccer Federation (WSF) to purchase 75 sets of U9-U10 sized goals to help implement the Long-Term Player Development (LTPD) model in Winnipeg. 15 sets of goals were provided to each of the district clubs so we could move to smaller sided games and more touches for our players based on the benefits of the LTPD model. The Association has been paying back the loan, however, in discussions with the WSF, they agreed to forgive the remainder of the loan at the end of the 2018-19 fiscal year amounting to \$24,722.

Booke & Partner were appointed as the Association's auditors for the 2018-2019 fiscal year at the 2018 WYSA Annual General Meeting. Upon conclusion of the 2018-19 fiscal year, the Executive Director engaged with Booke & Partner to facilitate the year-end audit providing them with registration data, invoices, and other documents for testing. The statements have been included in this annual report package. At the end of the 2018-2019 fiscal year, the association was in a deficit of \$5,250.

2018 OUTDOOR LEAGUE SEASON

In 2018, we continued to fine-tune our scheduling processes of implementing and sticking to a single day of play for all developmental league and premier league teams, meaning they played on the same day of the week (1 match per week). We have also made strides with recreational scheduling in working with many of our convenors and teams to avoid school conflicts. Across all leagues administered by WYSA for the outdoor season (U13-U18 Recreational, U9-U12 Developmental and U13-U17 Premier) we scheduled a total of 2,396 league matches and 295 jamboree matches. We had a total of 525 teams registered for the 2018 outdoor season; 366 in the U9 – U18 Recreation Leagues; 92







in the U9 – U12 Developmental Leagues; and 67 in the U13 – U17 Premier 1 & 2 Leagues. Congratulations to all our League and Cambrian Challenge Cup Champions who are listed in the Director of Outdoor report.

The 2018 outdoor season marked the fourth year in which all U9 – U12 participated in the Long-Term Player Development (LTPD) framework. The long-term player development model was developed to give players more touches on the ball, deemphasize scores and standings, and focus on coach education at the grassroots levels. With smaller sided games, more touches for each player, and less of an emphasis on winning and losing, we are confident over the long term, players and coaches will be better developed and enjoy the sport more, which will ultimately strengthen our game.

In 2013, in order to adapt to the smaller sided games and fields, WYSA purchased 75 pairs of 6'x16'



sized goals which were distributed amongst the 5 Districts to U9 & U10 fields. At the time, WYSA paid approximately \$50,000 from its reserves and received a \$100,000 loan from the Winnipeg Soccer Federation (WSF) to purchase the nets. In 2018, we began discussions with the WSF to have the balance of the loan forgiven at the end of the fiscal year and to their

credit, they agreed to forgive approximately \$25,000. We'd like to thank the WSF for their support in providing the funds and for their donation to WYSA.

At the end of the U9-U12 recreational and developmental outdoor seasons, WYSA again organized the season finale jamborees. The jamborees included 2-3 matches for every team, a free team photo at our photo booth station, food, and activities for each team such as the shot speed and shot accuracy stations. The 2018 event was sponsored by Valour FC and the feedback we've received was very positive. I would also like to personally thank the Board and Staff of Winnipeg South End United for their tremendous support and efforts in making the 2018 jamborees successful. We could not have done it without you! We must also recognize our MSA Provincial Championship teams that went on to represent Manitoba at the Canada Soccer National Club Championship. Heading into the final day, our







U15B Bonivital Blue squad had a chance for bronze but fell to Alberta 3-0, thus finishing in 4th place. Our U15G Bonivital Dreger, and U17B Bonivital Garrett both placed 7th, and the U17G FC Northwest McGrevy squad finished in 6th.

2018 BOSTON PIZZA PLAYERS TOURNAMENT

In 2015, the WYSA Board of Directors voted to create a player subsidy fund to help address the



shrinking subsidy funds available to youth soccer players and their families. This meant switching the recipient of our annual summer tournament proceeds from the Children's Hospital Foundation of Manitoba to a newly created player's subsidy fund. Over the 23 years, WYSA contributed more than \$300,000 to the Children's Hospital Foundation, which is due to the

tremendous support of our soccer community.

In partnership with Boston Pizza, we were able to raise another \$10,000 from the tournament and a total of \$43,000 over the last 4 years. Those funds are used to help support local soccer players and we are confident that the player subsidy fund will leave its own amazing legacy as interest and participation in the tournament seems to get stronger each year.

The 2018 tournament was a tremendous success with 175 teams participating (1 more than 2017), in 26 divisions for a total of 297 matches over the 5 days. Congratulations to all the teams that participated and continue to support our subsidy fund. We must also congratulate and thank all our volunteers and referees who help make the tournament such a great success.

2018 WYSA 3v3 TOURNAMENT

The 3v3 Tournament was introduced in 2015 and building on that we once again increased registration from 84 teams to 111 in 2018! Each year we've seen an uptick in registrations and this year's significant increase may









partially be credited to the tournament being hosted at IG Field. The one-day tournament guaranteed 3 round-robin matches for each team and finals for those that advance. We had a total of 192 throughout the day and 32 different referees to help execute the event!

2018 MOBILE MINI SOCCER PROGRAM

In 2015 WYSA took over the administration and operation of the Mobile Mini Soccer Program from the St. Charles Soccer Association. We continued to build on the program which offers a one-hour drop-in



session which teaches children the fundamental skills of soccer at 4 different inner-city schools through May and June. New this year, our district clubs selected their own coach coordinator for the 4 sessions they were assigned aided with volunteer teams to help with run each session. The WYSA Event Coordinator was responsible for overseeing the Coach Coordinator and ensuring he had the tools they needed for the program to run smoothly.

We also added a 5th school to the program, Wellington School and switched from Lord Selkirk to Greenway school. Each club did a tremendous job with the programming and the feedback from the schools and participants has been very positive. Below is a recap of the dates and locations of the program.

May 14th to May 17th – Weston School – St. Charles SA – 226 total participants (3 sessions) May 22nd to May 24th – Wellington School – Bonivital SC – 103 total participants (3 sessions) May 28th to May 31st – Greenway School – Winnipeg Phoenix FC – 115 total participants (2 sessions) June 4th to June 7th – Pinkham School – FC Northwest – 99 total participants (4 sessions) June 11th to June 14th – Brooklands School – Winnipeg South End United – 187 total participants (3 sessions)

In total, we have 730 participants which was down from 881 last year, however, we also had 3 fewer sessions than 2017. Over the 4 years of the program, we've had 2,813 participants. Speaking with the parents attending, as well as the school representatives, the majority loved the fact that this program was being offered and were very grateful for the chance to play soccer and learn from our premier players. Of the two new schools, Greenway was an instant hit. We had tons of kids attending and the







teacher coordinator did a fantastic job recruiting kids out. It was very unfortunate that two of the sessions got canceled at Greenway. Both Wellington and Greenway showed signs of potential growth with some continuity at those schools, but Pinkham had the lowest attendance this summer, despite having all four sessions run. Pinkham also has limited green space, so increased attendance may even hinder the program there. Most of the returning schools and very well attended, and excited to have us out. The new schools were well attended and eager to have us back (especially Greenway). I think this could also double as an information session for these core area community clubs as many parents also seemed unfamiliar with WYSA, or any organized youth soccer leagues in their area. If we could collaborate with local community clubs to have them come to maybe 1-2 sessions a week to be available to answer questions parents may have about where to sign up for soccer because that was a common theme.

2018 – 2019 INDOOR LEAGUE SEASON

The 2018-2019 indoor season kicked off on Saturday, October 13th at our traditional playing venues of the WSF Soccer North, WSF Subway Soccer South, and the University of Winnipeg RecPlex. The WSF facilities hosted both half-field and quarter-field matches, while the U of W RecPlex is only able to



accommodate quarter-field matches. We played on Thursdays (both genders), Saturdays (female only), and Sundays (male only) throughout the 20-week season. We had a total of 247 teams registered; 127 in the U9 – U18 Recreation Leagues, 78 in the U9 – U12 Developmental Leagues, and 42 in the U13 – U17 Premier 1 & 2 Leagues. As we moved to half field play, our number of teams have slightly decreased due to

teams playing 9v9 and carrying a higher roster number. WYSA is the league administrator for all leagues during the indoor season (U9-U18 Recreational, U9-U12 Developmental and U13-U17 Premier) we scheduled a total of 2,256 league matches. Thank you to all our indoor soccer convenors, staff, and







volunteers who help get teams registered and ready for play each season. As well, congratulations to all our League and Cambrian Challenge Cup Champions who are listed in the Director of Indoor report.

2018 – 2019 INDOOR HIGH SCHOOL LEAGUE

This season the Indoor High School League had the same number of teams as last year, 37 (18 male and 19 female), playing from October to March. Over the past 5 seasons, this program has grown in



popularity and with the new WSF Soccer North facility being built, the league has grown from 32 teams in 2016 to 37 in 2018. As we did last season, upon conclusion of the league season the top teams from the Championship division were promoted to the Premiership and the bottom teams from the Premiership were relegated to the Championship division for the Challenge Cup. The feedback has been fantastic with regards to scheduling, home/away matches, and the new league structure of the promotion and relegation.

We are hopeful to again grown the league in 2019 and have set our sights on 40 teams.

Congratulations to the League and Playoff Champions listed in the Director of Indoor report.

2019 GOLDEN BOY TOURNAMENT

The 2019 Golden Boy Tournament has been our most successful indoor tournament since WYSA began indoor programming. The tournament was held on February 14th – 18th at the WSF Soccer North and South, and, the University of Winnipeg RecPlex. We had a record number of teams register for the 2018 tournament, 180 (116 quarter-field & 64 half-field teams) across 26 divisions. We also had 36 non-WYSA teams participate, and of those 36, 31 of them represented out-of-province teams from Saskatchewan and Ontario.







We received many compliments regarding the event, such as the on-site athletic therapists, LOC communication, individual team packages, 50/50 and raffle opportunities, the overall website design, and how timely the results were posted. This year, we went digital with our 50/50 and raffle which



turned out to be cost-effective and efficient, which resulted in more sales than ever before. The merchandise continues to be a big hit and was available at all the playing venues and by the final day we had sold out of everything! Canteens were available at all tournament locations for the duration of the event. We had custom medals made for this tournament that were a huge hit with the participants and will continue to use those

medals in the years to come.

An evaluation survey was sent out to all team officials that participated in the tournament once the event was over asking for feedback on the event and what we can do to improve in the upcoming

years. Of note, the feedback from the tournament survey was that nearly 96% of respondents would participate in this tournament again and would recommend it to other teams.



My third year as Director of Outdoor with WYSA has been a great building experience. We continue to grow as an Association as we attempt to provide a better soccer experience for youth within the community.

First, I'd like to highlight all the hard work and dedication that so many in Manitoba give to improve



and grow soccer in this Province. From coaches, players, referees, district representatives, WYSA Staff and WYSA Board Members, there are a tremendous amount of people in Manitoba that go to great extents to ensure the continued improvement of soccer.

As our game is played all year with outdoor and indoor seasons. The stats show a total of 6,071 matches played throughout the outdoor and indoor seasons which is an impressive number. What



Independent Auditors' Report

To the Members of Winnipeg Youth Soccer Association Inc.

Opinion

We have audited the financial statements of Winnipeg Youth Soccer Association Inc. (the "Association"), which comprise the statement of financial position as at March 31, 2019, and the statements of financial activities and net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the financial statements present fairly, in all material respects, the financial position of the Association as at March 31, 2019, and the results of its operations and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Association in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Association's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.

Auditors' Responsibilities for the Audit of the Financial Statements

Winnipeg Youth Soccer Association Inc. Notes to the Financial Statements March 31, 2019

1. Nature of the organization

Winnipeg Youth Soccer Association Inc. (the Association) exists to promote and develop youth soccer in Winnipeg. The Association is a not-for-profit corporation pursuant to The Corporations Act (Manitoba) and is tax exempt under the Income Tax Act.

2. Summary of significant accounting policies

The Association follows Canadian accounting standards for not-for-profit organizations in preparing its financial statements. The significant accounting policies used are as follows:

a) Fund accounting

The Operating Fund accounts for assets, liabilities, revenues and expenditures related to the Association's equipment, youth registration, referee fees and administrative activities.

Assets, liabilities, revenues and expenditures designated for a special purpose are accounted for in the Restricted Fund. As there were no transactions during the fiscal year or balances at year end that were for a special purpose, a Restricted Fund statement of financial position and statements of financial activities and net assets were not required for 2019.

b) Revenue recognition

Revenues are recorded on the accrual basis. Grants received generally pertain to programs which run in the same year and, as such, are recorded as revenues when received and collectability is reasonably assured.

Tournament fees are recorded as revenue when collectability is reasonably assured and the event has occurred.

c) Amortization

Amortization is provided at rates designed to write off equipment over their estimated useful lives as follows:

Goal posts	10 years straight line
Computer equipment	5 years straight line
Furniture and fixtures	5 years straight line

d) Accounting estimates

The preparation of financial statements in accordance with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reported period. These estimates are reviewed periodically and are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

2. Summary of significant accounting policies - continued

e) Financial instruments

The Association recognizes its financial instruments when the Association becomes party to the contractual provisions of the financial instrument. Financial instruments are initially recorded at fair value with subsequent reporting at amortized cost.

It is management's opinion that the Association is not exposed to significant credit, currency, interest, liquidity, market or other price risk.

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Association is exposed to less than significant credit risk as receivable amounts are not material.

Currency risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in foreign currency rates. The Association is not exposed to currency risk as all transactions occur in Canadian currency.

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market interest rates. The Association is not exposed to interest rate risk as the Association has no external debt.

Liquidity risk is the risk that the Association will encounter difficulty in meeting obligations associated with financial liabilities. The Association has maintained positive working capital that minimizes its exposure to liquidity risk.

Market risk and other price risk are the risks that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market prices. The Association is not exposed to market risk as it has no material assets exposed to market fluctuations.

Management believes these risks are manageable and do not represent a threat to the Association's ability to continue as a going concern.
