Two Team Agreement for Suzie Que ORA #123456

[Who is the player and what is her situation] Example: Suzie is a 1st year Junior and will be playing on the Nith River U16A team and the Nith River U19B team.

[What is the association(s) reasons for requesting the 2-team contract] Example: The Nith River U19B team has 11 skaters and 1 goalie and has been using 1-3 substitute players for each game to date. Suzie has a sister on the team and has agreed to join the team as the 12th skater.

Priority as follows:

[This needs to be negotiated between the teams and agree by all parties. It does NOT need to follow the "standard" format. As per example #2 it may be tailored to the requirements of the parties involved as long as all agree.]

Additional notes for Games and Tournament play:

U19B will be missing at least 2 players for the Niagara tournament and therefore will have priority for this tournament only. The player will not be available for U16A games this weekend unless

the U19B team does not play on Sunday. For all other U19B tournaments, U16A scheduled games take priority.

For U16A tournaments, the player may still play a U19B game as long as (first) it does not conflict with the tournament schedule or team activities at the tournament. Second, the final decision in this situation will rest with the family as there are other players in the family whose game schedule may be a determining factor. (See also below re 2 games)

The player will not be available to the U19B team on Tuesday nights due to a non-ringette commitment. She will miss this commitment for the U16A team.

Under no circumstances (weather, travel time etc.) will the player play for the non-priority team and compromise a game for the priority team.

Under no circumstances will the player play more than 2 games in one day, if any of those games are for the non-priority team. If there is a conflict, all games for the priority team must be played. If there is only one game for the priority team, the player may play one game for the non-priority team but not more.
