# 11. Quorum

Twenty-five percent (25%) of the Members present or by proxy will constitute a quorum. If a quorum is present at the opening of a meeting of the Members, the Members present may proceed with the business of the meeting, even if a quorum is not present throughout the meeting.

# 12. VOTING AT MEETINGS OF MEMBERS

Voting Privileges – Registered Members will have the following voting rights via Delegate at all meetings of Members: Registered Members will be entitled to one (1) vote for every one hundred (100) players (U6LTS through 30+ Masters) registered with the Corporation in the past season (September 15 – September 14).
