Bench Staff Qualification Requirements:

There continues to be confusion over Bench Staff Requirements. I will be planning a meeting with all Association Coaching Directors in late September or early October to go over these requirements as well as other issues as they pertain to Coaching.

In addition the ORA is working on Professional Development Requirements for all coaches as required by the NCCP. All coaches will need to complete a certain amount of Professional Development over a five year cycle in order to maintain their certification.

The hope is that by having this meeting all associations will be up to date on all the current issues in the Province as it relates to Coaching.

2016 Coaching Clinics

Bench Staff Code of Conduct

All bench staff must sign the Bench Staff Code of Conduct Agreement (ORA Form C-F-01) and we trust that bench staff will adhere to both the letter and spirit of this Code of Conduct. We will be collecting the signed agreements at the November meeting. Please be sure to collect from your coaches and bring with you. We have had some issues with coaches around the province over the past few seasons including some from our own Region so I ask that coaches try to represent their team, association and Western Region appropriately during all sanctioned events.

Coaching Resources

There are various coaching resources, such as sample practice plans and videos, available on the Ringette Canada website (<u>www.ringette.ca</u>). In addition, Ontario Ringette has developed 'Guides to

Success' for U6 to U10 coaches and Associations. Ontario has also produced a 'Drills for Skills' index to help coaches quickly find effective drills to develop particular skills. These tools can be found at <u>www.ontario-ringette.com</u> => Coaching => Resources.

As was the case last season, the Region Coaching Coordinators have created a Sample Coaching Meeting Agenda including relevant links and information to help associations to ensure they include all relevant information in their initial coaching meetings.
