- Received Football Ontario Operation Grant to bridge equipment costs incurred without the support of tackle programming fees


Challenges

Constitution Changes

Change 1 -

Reason for change: Housekeeping

Type of change: Addition

Location: Article VIII, 8.1.a.6

Text to add:

A director shall not be a head coach of a high school football team.

Purpose: to maintain the Association's neutrality in support of all high school football programs

"A director shall not be a head coach of a high school football team" – Point of discussion. Shaun moved to change the motion to include any member of a high school football coaching staff. Michelle seconded the change.

New motion:

"A director shall not be a member of a high school coaching staff"

Annette motioned to approve, Shaun Fletcher seconded. 6 in favour.

Change 2 -

Reason for change: Housekeeping

Type of change: Addition

Location: Article IX, 9.6

Text to add:

No representative from the association's membership is eligible to be elected to the position of President unless the member has previously served (defined as in the past two years) at least one year as a voting member of the YRFA Board of Directors.

Purpose: to ensure consistency and continuity, and to reduce reputational risk.

New addition - Annette motioned that the board research adding a non recruiting clause into the constitution in 2022. Michelle 2nd. 8 in favour.

Change 3 -

Reason for change: Housekeeping

Type of change: Addition

Location: Article X, 10.10

Text to add:

It is the duty of the Board of Directors to maintain neutrality with high school football programs, and to ensure that no high school football head coach is named to a YRFA head coach position for age groups: U14/Bantam, U16/Junior Varsity, U18/Varsity.

Purpose: to maintain the Association's neutrality in support of all high school football programs

Jason Wilkinson motioned to change the proposed text to exclude all high school football coaches. Shaun seconded.

New motion:

It is the duty of the Board of Directors to maintain neutrality with high school football programs, and to ensure that no high school football coaching staff is named to a YRFA head coach position for age groups: U14/Bantam, U16/Junior Varsity, U18/Varsity.

Motion to approve as it sits amended: Annette motioned, Shaun seconded.

Motion Proposal for review of members

No high school football staff are permitted to recruit for a high school football team on a Lions field, while representing York Region Lions football.

Annette motioned, Michelle seconded, to be brought to next meeting of the members. All in favor (6).

- Should be a non compete, non soliciting
- YRFA is only interested in maintaining neutrality on the field we want kids to play high school football
