

Fund-Raising Guidelines

October, 2019

It is understood by the Yorkton Minor Hockey Board of Directors that teams may raise funds for their respective team. It is recognized that the funds raised are to be used for the betterment of the team as a whole.

The purpose of this document is to provide some guidelines for fundraising throughout the hockey season. It is not intended to provide answers to every situation that will ever come up. A common-sense approach must be taken as it should be acknowledged by all teams that excessive fundraising from one team in the local community may impact fundraising of the remaining teams. Further, excessive fundraising requests to local businesses can create a bad perception of YMH sustainability. In cases of inquiries, complaints and issues brought to the YMH Executive regarding a team's fundraising activities, all decisions by the YMH Executive will be final.

- YMH may decide to may participate in an association wide fundraiser. If so, all YMH registrants will be required to participate.
- All teams will participate in two main fundraising activities each year:
 - a. YMH home tournaments, as scheduled by the YMH Board of Directors; and,
 - 50-50 draws at each home game.

NOTE: YMH teams can only receive a maximum of \$150 per player back from home tournament profits, any additional profits will be returned to YMH to help cover the cost of jersey and equipment replenishment.

iii. Additional team fundraising activities are allowed. YMH Board of Directors may impose limits on team fundraising and or set maximum team budgets in preliminary budgets show excessive fundraising activities are being planned.

Additional team fundraising activities must be discussed and approved by the majority at a team parent meeting. Player families who choose not to participate, for whatever reason, should be provided with an alternate amount to pay in lieu of fundraising – this too should be agreed upon by the majority at a team meeting.

All fundraising activities should operate within the law and YMH accepts no responsibility whatsoever for any lack of payment which is the sole responsibility of the team

Use of YMH logos and letterhead is only allowed when obtained from YMH Executive Director.

iv. All fund raising activities are to be included in the team's financial reports.

Section 32 of YMH Constitution:

".... proposed budgets shall be submitted within four weeks of team formation to the Executive Director of Yorkton Minor Hockey. A year-end financial statement should be provided to the Executive Director of Yorkton Minor Hockey within six weeks of the team being finished for the season.

Copies of the proposed budgets and yearend financial statement should be provided to the parents of the respective teams at the same time."

- v. Parents/players <u>cannot</u> individually profit from the team fund-raising activities. Each individual parent/player account is to be treated as a not-for-profit situation. A player/parent shall not get back at season end more than they contributed in actual dollars. i.e. if a person has contributed \$135 to the team, and fundraised \$665 for a total of \$800, with actual spending of \$600, then they can only receive \$135 back at year end. The additional \$65 is to be used on a team windup, donate funds to YMH or, donate to Jumpstart (or other type charitable organization).
- vi. Teams using social media to promote their fundraising activities should be mindful of the YMH Social Media Policy and should not directly tag YMH social media pages in their post.
